#### **II BUDGET FOR THE YEAR 2009-2010.**

Resumption of general discussion on the Budget Estimates for the year 2009-2010.

S/shri Anand Singh Dangi, Smt. Geeta Bhukkal, Nirmal Singh, Smt Parsanni Devi, S. S. Surjewala, Ramesh Gupta, Subhash Chaudhry, Jagbir Singh Malik, Randhir Singh, Karan Singh Dalal and Prof. Chhattar Pal Singh, Members from the Treasury Benches, spoke for 51, 20, 12, 12, 17, 10, 11, 10, 9, 16 and 15 minutes respectively.

S/shri Harsh Kumar, an Independent Member, spoke for 28 minutes.

S/shri Balwant Singh Sadhaura and Sahida Khan, Members from the Indian National Lok Dal, spoke for 10 and 11 minutes respectively.

#### **III ANNOUNCEMENT BY THE CHIEF MINISTER.**

During the course of general discussion on Budget for the year 2009-2010, the Chief Minister, with the permission of the Speaker, made an announcement regarding enhancement in the amount of old-age pension for old-aged persons and the new name of this old-age allowance scheme will be 'Vridha Awastha Samman Bhata Yojna.' and also announced that old aged men and women will also be honoured with 'safa' and 'doga' and with 'shawl' respectively.
