To Make Delhi Road Traffic Jam Free

*1293. Dr. Kamal Gupta, M.L.A.: Will the Deputy Chief Minister be pleased to state whether there is any proposal under consideration of the Government to make main Delhi Road of Hisar City traffic jam free by constructing elevated road; if so, the details thereof?

Total Number of Schools

*1470. Shri Nayan Pal Rawat, M.L.A.: Will the Education Minister be pleased to state the total number of Secondary, High and other Schools in State together with the number of students studying therein along with the total number of teachers, cleaning staff, chowkidars and peons posted therein?

Recruitment of Drivers and Conductors in Roadways
