**To Construct the Roads**

**1 Dr. KRISHAN LAL MIDDHA (Jind):**

Will the Deputy Chief Minister be pleased to state:-

a) whether there is any proposal under consideration of the Government to construct any new road for direct entry from by-pass (NH) to under construction medical college in Jind city; if so, the time by which it is likely to be constructed; and

b) whether there is also any proposal under consideration of the Government to increase the connectivity of medical college after transforming the non-functional distributary into the road; if so, the time by which it is likely to be constructed?

**To Construct the Ring Road**

Will the Deputy Chief Minister be pleased to state:-

a) whether there is any proposal under consideration of the Government to

construct a ring road of the Jind city; if so, the time by which it is likely to be constructed;

c) if so, the time by which the DPR is likely to be prepared?

b) if so, the time by which it is likely to be upgraded?

### **Amount Released to the Panchayats**

#### **4 Sh. BISHAN LAL SAINI (Radaur):**

Will the Development and Panchayats Minister be pleased to state:-

a) whether it is a fact that approximately 160 villages and three blocks i.e. Radaur Block, Jagadhri block and Saraswati Nagar block are falling under the Radaur Assembly Constituency;

b) the amount released to the panchayats from the NGT and other schemes to those villages of three blocks which are falling under the Radaur Assembly Constituency after the 25<sup>th</sup> February, 2021 togetherwith the details of the account in which the said amount was deposited; and

c) the details of the development works which have been executed from the abovesaid amount and the details of the development works which are lying incomplete?
