To Complete the Construction Work of Bridge

*121 Sh. Harinder Singh (Hodal):

Will the Public Works (B&R) Minister be pleased to state:-

(a)whether it is a fact that an announcement was made by the Hon'ble Chief Minister to construct a bridge on Yamuna River in Hasanpur;
(b) whether it is also a fact that the construction work of abovesaid bridge has almost been completed on the border side of Uttar Pradesh; and

(c) the time by which the remaining construction work of abovesaid bridge on the side of Haryana is likely to be completed?

To Construct the Roads

Will the Public Works (B&R) Minister be pleased to state whether there is any proposal under consideration of the Government to construct the following roads: -

a) damaged road from village Matanhail to Salhawas via Mundsa, Bhiror,

b) if so, whether there is any proposal under consideration of the Government to shift the said dumping yard and its garbage to another place away from the villages togetherwith the details thereof?
