REPORT

1. The Estimates Committee for the year 1979-80 consisting of nine members was elected by the Vidhan Sabha and notified vide Haryana Vidhan Sabha Secretariat Notification No. EC-3/79-80/31, dated, the 14th May, 1979, under Rule 230 of the Rules of Procedure and Conduct of Business in the Haryana Legislative Assembly.

2. Shri Des Raj, M.L.A., was nominated Chairman of the Committee by the Hon'ble Speaker.

3. The Committee held 41 sittings at Chandigarh and 7 sittings outside Chandigarh i.e. two at New Delhi and one each at Darjeeling, Gangtok, Calcutta, Bhubaneswar and Puri.

The Committee selected the following Departments with a view to scrutinise their Budget Estimates for the year 1979-80.

#### 1. Irrigation;

#### 2. Industries;

#### 3. Transport;

#### 4. P.W.D. (B&R); and

#### 5. Education.

4. (a) The Committee scrutinised the material relating to the Budget Estimates of the Education Department and Irrigation Department for the year 1979-80 and orally examined the representatives of these Departments.

(b) The Committee also scrutinised the Supplementary Estimates for the year 1979-80 and presented its report to the House accordingly.

(c) The Committee also desires that the government should strictly adhere to the recommendations made by its predecessor Committee for the year 1978-79 in Para 7 of its Eleventh Report. The Supplementary demands should be brought before the House only in the cases of emergent requirements for the works of Public importance.

### EDUCATION DEPARTMENT

#### 5. Organisation of the Department & its Subordinate Offices

Organization of the office of the Director of Public Instruction, Haryana (Headquarters-Directorate).

##### 1. Introduction

The Education Department is one of the biggest Department of the State. It is being headed by an I.A.S. Officer. In view of rapid

development in various spheres of activities relating to School & College Education and enormous increase in the Number of Educational Institutions, Teachers, it has become well nigh impossible for a head of department to cope with the increased rush of work. Therefore, Government have created an other post of I.A.S. Cadre with the designation of D.P.I. (Schools) and the incumbent of this post has been entrusted most of the responsibilities in the field of school Education. These officers are assisted by Two Joint Directors, One Director State Resource Centre, Joint Director Adult Education, Five Deputy Directors, One Administrative Officer, Ten Assistant Directors, Registrar, Budget Officer and two Accounts Officers, besides the Ministerial staff.

So far as the field offices are concerned, the Principals of Government Colleges, Director, S.C.E.R.T., District Education Officers, State/District Libraries, are functioning under him.

#### B. ORGANISATION OF SUBORDINATE OFFICES (FIELD)

1. Distt. Education Officer 11 Rs. 700/1200

**General**

At the time of reorganisation of the Punjab State with effect from 1st, November, 1966, 7 posts of the Distt. Education Officers (3 in HES Class-I & 4 HES Class-II) were allocated to the State of Haryana. In order to strengthen the Educational Administration in the field, the Status of all Class-II posts of D.E.O.'s was raised to HES Class-I of Sept. 1967. Further in order to tone up efficiency, all the D.E.O.s were made directly responsible to the Director by abolishing the office of C.E.O. Ambala in Oct., 1967. There are 11 Distt. Education Officers for all the Distts of the State, at present. Government of India have now launched a time bound programme of Adult Education. The Administrative structure of this scheme at Headquarter and field level is shown as under.

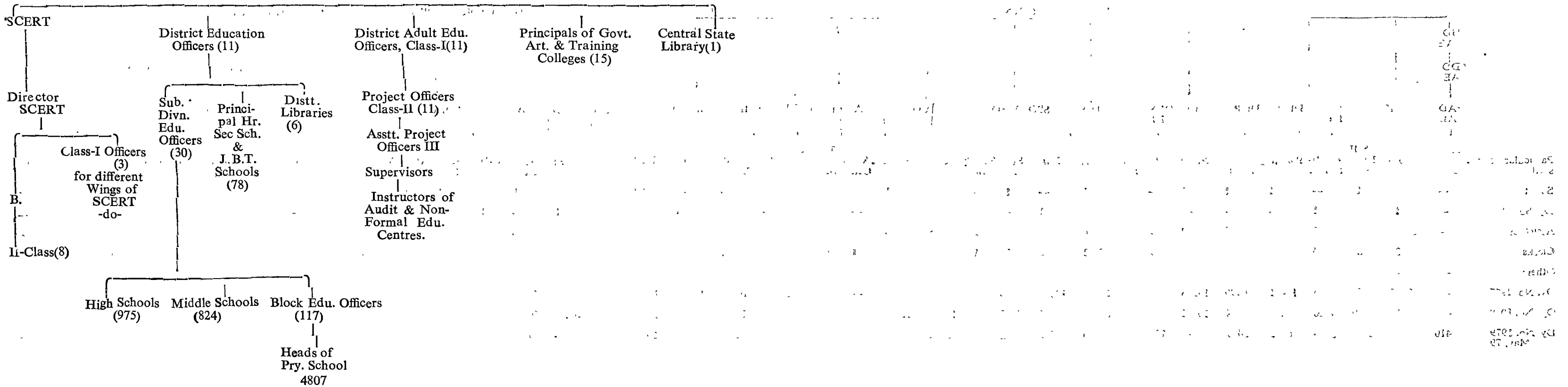

## 6. FUNCTIONS/DUTIES OF THE DISTT. EDU. OFFICERS

The Distt. Education Officer is the head of Educational Administration at Distt. Level and his duties, inter-alia include inspection, control and supervision of all educational activities right up to higher secondary level and implementation of Government educational policies in the field. He functions as the appointing and punishing authority in respect of the teachers working within the District. He is responsible to ensure that the existing facilities in the field of education are geared to maximum use and the tempo of development is maintained in keeping with the people's urges and aspirations consistent with the available resources. He is to carry out regular inspection of Higher Secondary Schools.

The District Education Officer is further required to carry out snap inspections of some middle, high/higher secondary schools to ensure that the work of inspection of schools is being performed diligently and efficiently. He is also to pay surprise visits to all categories of schools in the District with a view to check up truancy in schools.

Side by side with inspection of institutions, the District Education Officer has to keep an eye on the efficiency of his own office and that of the S.D.E.O./Block Education Officers under him. For ensuring the toning up efficiency in these offices he is required to carry out regular inspection of his field offices. He is also to take follow up action on his inspection reports suggest measures for improving efficiency and removing bottlenecks. He is also to ensure that statistical data in respect of educational activities in his district is accurately compiled and maintained. Supervision of the work of Auditor is also his assignment. For this purpose he has to satisfy himself about the genuineness of the assessment of grants, etc made by the Auditor in each individual case inter-alia by keeping a close touch with the reports received from the Directorate. He acts as Drawing & Disbursing Officer in respect of pay, T.A. and contingencies for his office as a whole. So far as arrears in the disposal of papers are concerned the District Education Officer is not only to ensure that no arrears are allowed to accumulate but the periodical returns/reports which his office has to submit are also sent regularly and punctually. Alongwith this he has also to see that the ACR.s on the work & conduct of teachers/masters and ministerial staff are written in time and placed on the relevant personal files which are maintained in his office, and the ACRs which are to be submitted to the Directorate are despatched to the Headquarters with promptitude.

The District Education Officer is also responsible for the preparation of Budget Estimates in respect of his office and other offices and institutions under him. To safeguard against likely defalcations he has to conduct reasonable physical verification of cash held by the cashier, and Store and stocks being maintained by the Store Keeper.

In fact, the District Education Officer is the king-pin in the educational administration in the District. For efficient and intelligent

discharge of any of the abovementioned functions the District Education Officer may take the active assistance of his/her Deputy Education Officer.

**The other Functions of District Education Officers are Detailed Below :**

- (i) Confirmation, fixation of seniority, disciplinary matters, efficiency bar cases, Pension cases of Masters/Mistresses, Lecturers/Assistants/Clerks, Head-Clerks etc. temporary advances of G.P. Fund to Non-Gazetted Government servants, inspection of schools in the district.
- (ii) Minor/Major penalty cases of teachers borne on the district cadre appointed after 19.1.62, release of selection grade to teachers and maintenance of service records of Heads of Hr. Sec. Schools and S.D.E.O's of the District.
- (iii) Merit Scholarship to students, opening of new schools and upgrading of schools and all kinds of statistics of the district.
- (iv) Various types of grants to privately managed institutions.
- (v) To write off articles purchased out of Pupil's Funds to the extent of Rs. 500/-
- (vi) Repair of school furniture upto the extent of Rs. 1000/-per year.
- (vii) Recruitment of lecturers (School Cadre) through Employment Exchange for a period of six months.
- (viii) To promote masters/Mistresses as lecturers on seniority-cum-merit basis for period of four months.
- (ix) To grant permission to teachers to appear in various Exams.
- (x) Maintenance of personal files of B.A./B. Eds. Masters/Mistresses in the District. Besides various powers have been delegated to them as laid down in CSR Vol. I, II & P.F.R. Vol. I.
- (xi) Holding of enquiries in complaint and other cases.

## 7. THE FUNCTIONS OF THE SUB-DIVISIONAL EDUCATION OFFICERS

- (i) Inspection of Middle/High Schools, all powers of drawing & disbursing officers of Middle schools, writing of annual confidential reports of heads of Middle and High Schools/Block Education Officers, Submission of efficiency bar/confirmation/seniority/selection/grade/extension/pension cases of the staff working in middle schools, complaints and enquiries of middle high schools, appointment of teachers/masters on six months basis in middle schools.

- (ii) Collection of all types of information in respect of middle high schools, Harijans Welfare Scheme, Scholarships & stipends cases of middle schools.
- (iii) Maintenance of personal files of teachers & conveying of adverse remarks to them,
- (iv) Reimbursement of medical charges not exceeding to Rs. 200/- to B.E. O'S and their staff and to the teachers of the High /Middle/Primary Schools.
- (v) Sanctioning journey beyond jurisdiction in respect of Middle Schools.
- (vi) Preparation/consolidation of budget, nominal rolls and expenditure statements under various schemes relating to middle schools.
- (vii) To write off articles purchased out of pupil funds upto Rs. 150/-
- (viii) Repair of school furniture under pupil funds rules, 1972 upto Rs. 750/-
- (ix) To maintain cash book, Store & Stock registers and Acquittance rolls,

Besides various powers have been delegated to the Sub-Divisional Education Officers under the CSR Vol. I, III and P.F.R. Vol. 1.

#### **Functions of the Block Education Officers-117 Posts in Rs. 300/600**

The Block Education Officers are generally drawn from the cadre of Headmasters/Headmistresses and are responsible for the inspection of Primary Schools functioning under them at least once in a quarter. They are directly responsible to the Sub-Divisional Educational Officers for proper functioning of these schools in their respective jurisdiction. It is one of their main function to ensure that the staff is fully employed in the school and the available facilities are geared to maximum use. They have to report regularly any shortfalls in the sanctioned strength of the schools and also to see that in case of over-crowding the demand for more staff is communicated to the S.D.E.O. in time.

The B.E.O. is also incharge of his own office. He is the Drawing & Disbursing Officer in respect of Primary School teachers and in consequence he has to ensure the timely sub-mission of various periodical reports and returns to the SDEO. He has also to see that the character rolls of teachers under him are kept upto-date and their service books and leave accounts brought upto-date. He is responsible for proper maintenance of Cash Books, Store & Stock registers and acquittance rolls.

#### **8. STATE/DISTRICT LIBRARIES**

One State and Six District Libraries are functioning in Haryana.

The usefulness of a library is acknowledged on all hands. In fact it is one of the most important adjuncts of good education.

## 9. PRINCIPALS OF COLLEGES-15 POSTS

A Principal of a College is responsible for University Education in his college. He is head of the institution and head of the college Office, Excluding inspection, a Principal has to discharge all functions in respect of his college as in the case of DEOs and SDEOs. He is a teacher in so far as his teaching work is concerned. He is an administrator in so far as the administration/supervision/control of the college is concerned.

12. Payment of Scholarships and stipends to the students in Schools and Colleges including the award of freeship and stipends to the students belonging to Scheduled Castes/Tribes & Backward Classes.
13. Promotion of NCC/NSS Activities in the State.
14. Collection of Educational Statistics.
15. Taking over of Privately managed schools/colleges.
16. Grants-in-aid to Universities.
17. Preparation of budget estimates, maintenance of accounts & control over expenditure.
18. Levying of fees, fines and institution of Pupil funds in schools and colleges.
19. Boys Scouts & Girls Guide movement, Physical Education.
20. Medical inspection of students of Schools, Colleges.
21. Maintenance & development of State Library, Amabala & Distt. Libraries.

22. Non-formal and Adult Education Schemes.
23. Making arrangements for mid-day meals for children studying in Primary classes,
24. To bring about qualitative improvement in school education, organizing in service courses for teachers' to review, revise and write school books, Conducting surveys and research in the area of education and to reform the present system of Education through the newly set up State Council of Educational Research and Training at Gurgaon.

## NCC ORGANIZATION

The organisational set up in respect of N.C.C. Scheme at the Directorate level is attached as Annexure 'A' at Page 17.

All the powers as enshrined in the N.C.C. Act, 1948 for Directors of Education are exercised by the Director of Public Instruction, Haryana. He enjoys full powers in respect of civilian staff posted to the various Battalions in the State and also functions as Controlling Officer of the budget sanctioned for this purpose by the State Govt. The work in this respect is also looked after by the Joint Director Colleges and the Assistant Director (A.D.C.C.) as per N.C.C. Act. N.C.C. which was introduced in the year 1948 for imparting training in schools and colleges as governed by N.C.C. Act and rules formed by Govt. of India. It is being run jointly by the Central and State Governments with their well defined responsibilities and powers. N.C.C. training is imparted to the cadets in all the three wings of Armed Forces i.e. Army, Navy and Air. The Senior Division caters to the needs of the colleges and Junior Division to schools. There are girls companies/troops in both the senior and junior Divisions. The strength of the cadets in various wings is fixed by the Director General, N.C.C., New Delhi.

The Central Govt. bears 50 % of the expenditure on the scheme by providing (i) Regular Army Officers and Instructors for the supervision and training of cadets (ii) clothing and equipment (iii) Arms and ammunition and other equipment required for training. Besides it 50 % of the camp expenditure incurred by the State Govt. is reimbursed to it by the Central Govt. The State Govt. provides funds for expenditure on civilian staff viz. Clerks, Drivers, Lascars, Peons, Chowkidars etc. in N.C.C. Battalions and payment of honorarium of N.C.C. Officers, expenditure on renting of building, expenses on telephone, office equipment, refreshment to N.C.C. cadets, washing allowance etc.

## NATIONAL SERVICE SCHEME

The National Service Scheme was introduced in the colleges in Haryana in the year 1970-71 with an initial strength of 4,000 volunteers. Over the years it has grown and the strength now stands at 12,000. It functions through the three universities namely, Kurukshetra University, Maharishi Dayanand University and Haryana Agriculture University to which various colleges in the State and the Teaching Deptt. of the Universities are affiliated. Each College/Teaching Deptt. has predominantly one unit, comprising 100 volunteers. Universities have employed Programme Co-ordinators (Whole time and part time) to look after the activities of the scheme. At the Directorate level an Officer of the rank of Assistant Director co-ordinates the functioning of the scheme under the direct supervision of the Director of Public Instruction, Haryana. The State has been divided into 11 zones. The member colleges select their own Convenor and Chairmen.

To effectively guide and look after the activities of the scheme there exists a State Advisory Committee under the Chairmanship of the Education Minister, Haryana. In order to obtain cooperation and assistance from various Departments, an Inter Departmental State Committee was formulated which functions under the Chairmanship of Secretary, Education Deptt. At the University level an advisory committee looks after the activities and review them. It also sanctions necessary funds for the office establishment.

The work in National Service Scheme is so designed as to enrich the students personality, deepen their understanding of Social environments and inspire them to promote social welfare. Every college having N.S.S. unit was asked to adopt at least one village/slum area for extensive work i.e. eradication of illiteracy, slum clearance, socio-economic work, improvement of sanitation, plantation of trees and prevention of soil erosion, preservation of Historical monuments, popularisation and construction of gobar gas plant, eradication of dowry and other social evils, rodent control, weed and pest control

The work of N.S.S. is classified in two broad heads (i) regular activities, which goes on in the adopted villages broadly on the subject shown in the above para and (ii) the special camping programme, which is carried out as per instructions of the Govt. of India. The work is got evaluated by the Delhi School of Social Work and other similar institutions in the country. The main guide lines in this regard are issued from time to time by the Ministry of Education and Social Welfare, Govt. of India. Their present campaign is "Youth for Rural Reconstruction and Afforestation." The expenditure on the scheme is proportionately borne by the Central and State Govts. in the ratio of 7 : 5. Total Budget Provision for the year 1979-80 for the 12,000 students is 14.40 lacs. The financial provision is according to the norm fixed by the Govt. of India. The expenditure on the various items has also been enunciated by Govt. of India.

## STATE COUNCIL OF EDUCATIONAL RESEARCH AND TRAINING, HARYANA GURGAON.

During the year 1978-79, Haryana Govt. accorded sanction to the setting up of State Council of Educational Research and Training

at Gurgaon by merging the State Institute of Education and State Institute of Science Education. All the posts existing in the two institutes were retained and in addition, the following posts were also sanctioned.

1. One post of Class I Officer in the grade of Rs. 700/1200.
2. One post of Steno Typist in the grade of Rs. 110/225 plus Rs. 25/as Special pay.

The amount sanctioned for the above posts and other contingent charges etc., for the year 1979-80 is Rs. 27,390/-

In fact, the merger of the two institutes took place when the Director was appointed in April, 1979. The scheme wise expenditure sanctioned by the Govt. for the year 1979-80 is given below :—

2. To plan and organise Inservice training courses for teachers, Heads of all categories for their professional growth.
3. To review, revise and write school books.

6. To work on reforming the present System of education.
7. To disseminate improved techniques and Practices in Educational institutions.

#### **NATIONAL ADULT EDUCATION SCHEME**

The Organisation under this scheme is as follows:

##### **A. Headquarter Staff**

At the apex the Director of Public Instruction is the over-all

incharge of the programme. He is assisted by a team comprising the following officers :—

One state Resource Centre has also been set up. It will function as the academic wing of the organisation. One post of Director, 5 post of Research Officers and other ancillary staff has been sanctioned for this centre.

#### B. Field Staff

In the field one post of Distt. Adult Education Officer, one project officer, one post of Asstt. Project Officer and other ancillary staff have been sanctioned for each district. 10 posts of supervisors at the rate of one supervisor for 30 centres and 300 part-time instructors have been given.

The function of the administrative wing at the Directorate is to plan, organise and execute the scheme. The state Resource Centre will arrange for the training of the personnel produce new literature and monitor and Evaluate the programme. The function of the Distt. Adult Education Officers, Project Officers and Asstt. Project Officers are supervisory administrative and co-ordinating. They have to make necessary arrangements to promote the programme and implement the scheme successfully. The supervisors have to inspect the centres/contact the villagers and other agencies to ensure the smooth running of the centres. The instructors have to do the teaching work.

The staffing pattern follows that indicated by Government of India.

#### CARE SCHOOL FEEDING PROGRAMME

Initially scheme for the free distribution of Milk to Primary Schools Children was introduced in composite Punjab in the beginning of 1962 in collaboration with philanthropic organisation of U.S.A. commonly known as CARE (Co-operative for American Relief every where). The Scheme was being operated by the Development Department up to 31st March, 1968 and from 1st April, 1968 to onward it is being implemented by the Education Department independently in 83 out of 117 Educational Blocks covering 3953 rural Primary Schools in Haryana State. Under this scheme Corn Soyabean Blend, Soya Fortified Bulgur, Salad Oil, Balahar are distributed under the supervision and over-all control of the Block Education Officers concerned.

During the year 1976-77, with the help of Care Organisation 6 Regional Godowns were constructed at Centrally located places where food commodities are being stored properly. Incharge CARE Regional Godown supply the CARE commodities to the various Block Edu-



ation Officers concerned. These commodities are distributed to children of Primary Schools of rural areas. Every child covered under this scheme is given 80 grams of Cereal and 7 grams of Salad Oil as daily ration. The food stuffs supplied by CARE are cooked with the help of students. It contains vitamins, Minerals and amino acid to over-come mal-nutrition when served to children daily.

Besides, in order to supply 'Ready to eat food' to school children a Central Kitchen has also been set up at Gharaunda (Karnal). At present, it caters the need of 40 thousand children in 12 Educational Blocks and 100 grams Panjeeri is given per child per day.

The State Government is required to bear the following charges in order to implement this scheme properly :—

1. Railway freight from the Port to the places of destination in Haryana State.
2. Payment of Organisational Charges to CARE including the cost of CARE commodities which are damaged or lost in the custody of the state for the reason other than natural calamities.
3. Transportation charges from the Railway Station in the state to the places of storage and therefrom to the school.
4. Rent of stores and Regional Godowns.
5. Salaries to Chowkidars and Honorarium @ Rs. 10/- P.M. to each of the clerks attached to the Block Education Officer of the Blocks where the scheme is in operation.
6. Pay and allowances of the staff employed at Headquarter as well as regional Godowns Central Kitchen Gharaunda.
7. The cost of sugar, water and electricity charges of central kitchen Gharaunda.

The Entire Expenditure of items 1 to 7 on this scheme is met out of the sanctioned grants provided for the purposes in the budget of the Education Department.

In order that no brilliant student is prevented on the ground of poverty alone from pursuing an academic career, National scholarships scheme for the award of Merit scholarships for the post-Matric Education has been introduced by the Government of India with effect from the year 1961-62. The scholarships are awarded strictly on merit on the result of Matriculation, Hr. Secondary and Degree Examinations and First Degree professional Examination for the full duration of the course. The number of fresh scholarship fixed for 1979-80 is 455.

The quota of fresh scholarships for the year 1979-80 allotted to the Haryana State is 12. These scholarships are awarded in the ratio of total number of applications received in each of the above examinations. ### 3. SCHEME OF STATE GOVT. OF HARYANA, EDUCATION DEPARTMENTS MERIT SCHOLARSHIPS IN COLLEGES FOR GENERAL UNIVERSITY EDUCATION

Budget Provision

Rs. 4,15,020 (Non plan).

In a large number of cases brilliant students are unable to pursue higher study due to lack of financial resources. Not only does this result in their own career being blighted but it also causes loss to the community as a whole which would ultimately have profited by their services had it been possible for their talent to flourish. In order that no really brilliant student is prevented on grounds of poverty from pursuing an academic career and with a view to giving them a sense of belonging as also an active awareness of their duty to the community, the State Govt. has formulated a scheme for award of Merit-cum-poverty scholarships to the poor (Economically backward classes), but talented students in colleges for general university education for Degree, Post-Graduate and Doctorate courses.

The Merit scholarships are awarded on the basis of the results of Matriculation/Higher Secondary, Pre-University and B.A./B.Sc. courses in colleges to poor brilliant students on the basis of Merit. The rates of scholarships vary from Rs. 22/- to Rs. 110/-P.M. There are 332 fresh scholarships for all courses under this scheme. These are awarded the Directorate receipt of the recommendations/applications from the examining bodies in the State. The scholarships once awarded on the basis of results of Hr-Sec., Pre-University and B.A./B.Sc. are renewed annually up to the 1st degree and Post-Graduate level respectively. There is one scholarship of the Value of Rs. 300/- P.M. for Ph. D course at Jawahar Lal Nehru University, New Delhi. The amount of scholarship is drawn at the Directorate level in respect of studying in Chandigarh and is remitted to the Heads of Institutions concerned through Bank draft/R.T. Rs. The amount of scholarships in respect of scholarship studying in privately managed institutions is drawn at the level of Distt. Education Officers and in respect of Govt. Institutions, the Head of the Institutions concerned draws the amount.

### 4. AWARD OF HARYANA GOVT. SCHOLARSHIPS TO HARYANAVI STUDENTS IN SAINIK SCHOOLS

Budget Provision.

Rs. 22,60,000/-(Non Plan)

The scheme for the award of merit scholarships in Sainik schools/Public School, Nabha was originated in the erstwhile Punjab State during the year 1961-62 so that the promising children of poor families are able to derive benefit from this education substantially. The

scheme has been continued in Haryana. It aims at preparing promising children for the National Defence Academy Examination. The Scholarships are awarded to Haryanavi students for 7 academic years according to the income of their parents/guardians as detailed below.

The number of scholarship has not been fixed as it depends upon the admission of children in Sainik schools. Since number of candidates in each income group will vary from year to year, the scheme is flexible in this respect,

#### 5. MIDDLE SCHOOL SCHOLARSHIPS

Budget Provision Rs. 3,65,040/- (Non Plan).  
Rs. 60,000/- (Plan).

1014 Middle school scholarships for Boys and girls at the rate of Rs. 10/- p.m. are awarded by the Distt. Education Officers to the students on the result of Middle schools scholarships examination, held during the month of Feb/March, each year. These scholarships are awarded in accordance with the order of merit on the pass list of candidates district-wise subject to the conditions that :—

- (i) Income of the parents/guardians does not exceed Rs. 6000/- P.A.
- (ii) The students joined the next class in any recognised schools of the State within a month of award.
- (iii) The age of the students (boys) in case of open school scholarships does not exceed 13 years on the 31st March, of the year in which they take examination.
- (iv) Parents/guardians actually reside in rural area for the award of rural area scholarships.
- (v) The students are domicile in Haryana State.

The final award rolls for these scholarships are issued by the Distt. Education Officers concerned.

Besides the above mentioned 1014 scholarships 500 new scholarships will be awarded during the year 1979-80 under the Plan scheme.

## 6. HIGH SCHOOL SCHOLARSHIPS (MERIT)

Budget Provision Rs. 2,40,480/ (Non Plan).

Rs. 1,55,000/-(Plan)

Haryanan State awards High school Merit scholarships every year to poor brilliant boys and girls students in order of merit on the basis of Middle standard examination conducted by the Haryana Education Board. During the year 1979-80, 668 fresh scholarships under the Non Plan scheme and 850 scholarships under the plan scheme will be awarded in the IXth class, besides the renewal of 668 scholarship after IXth class at the rate of Rs 15/-P M. The annual income of the parents/guardians should not exceed Rs. 500/-P.M.

The students should be domiciled in Haryana State.

## 7. TEACHNG OF TELGU LANGUAGE AS THIRD LANGUAGE AT MIDDLE LEVEL SCHOLARSHIPS IN SECONDARY SCHOOLS.

Budget Provision Rs 37,440/-(Non Plan).

Under tne scheme of introduction of Telgu language the Haryana Govt. has provided scholarships at the rate of Rs 10/-P.M. per studenr to the students standing First, Second and Third positon in T.lgu language in the quarterly examination at the schools. The scholarships awarded to students in VIIth and VIIIth classes studying Telgu language. 153 scholarships are awarded in each class.

## 8. AWARD OF SCHOLARSHIPS TO THE STUDENTS STUDY-ING SANSKRIT IN HIGH/HIGHER SECONDARY SCHOOLS.

Budget Provision. Rs 6000/-(Plan)

Scholarships of the value of Rs. 10/-P.M. each are awarded to the students studying Sanskrit as one of the elective subjects in IXth, Xth, and XIth classes, in order to popularise the study of Sanskrit in the schools. The Govt. of India, Ministry of Educ. tion, originated the scheme in composite Punjab State with 50 scholarships during the year 1963-64. 20, out of 50 scholarships have come to the share of Haryana after re-organisation. The requisite amount is at first provided in the State Budget and later on the actual expenditure is re-imbursed by the Govt. of India on cent per cent basis.

## 9. NATIONAL SCHOLARSHIPS SCHEME FOR THE TALENTED CHILDREN FROM THE RURAL AREAS AT SECONDARY STAGE.

Budget provision Rs. 2,73,070/-(Non Plan)

In order to provide scholarships at the Secondary stage to the talented students hailing from rural areas and also to involve a place-

ment programme in the sense of securing admission in selected good schools, the Govt of India, launched a National Scholarships scheme from the year 1971-72. Under this scheme 6 scholarships per community Development Block are required to be awarded and these scholarships are tenable for 3 years i.e. from 9th to 11th classes. These scholarships are awarded on the basis of Middle school examinations conducted by the Deptt.

The scholarships once awarded continue on year to year basis subject to the conditions laid down under the scheme.

According to the decision of Govt of India, the expenditure equal to the amount spent on this scheme in the year 1973-74 will be the responsibility of the State Govt. and the additional amount, if any, incurred will be reimbursed by the Govt. of India Ministry of Education and Social Welfare.

#### 10. GOVT. OF INDIA MERIT SCHOLARSHIPS IN RESIDENTIAL SCHOOLS

Budget Provision.

Rs. 1330/- (Non Plan).

Just to discover potential talent and intelligence, the Govt. of India have formulated a scheme for the award of Merit scholarships to the students of age-group 11-12 years in the residential schools. The State Govt is desired to incur expenditure for the payment of T.A. to the candidates, remuneration to paper setters, translators examiners etc. and also cost of printing of question papers under the scheme.

#### GOVT. OF INDIA NATIONAL LOAN SCHOLARSHIP SCHEME

Budget Provision 1979-80

Rs. 4,10,000/- ( : Plan)

Though a large number of scholarships and fellowships have been instituted in recent years but they still do not measure upto the problem of higher education. In order to provide financial assistance to needy and meritorious students for the completion of their education and to provide an incentive to brilliant students to take up teaching as a profession, a scheme for the award of loan scholarships has been introduced by the Govt of India with effect from 1963-64. The loan scholarships are available for studies in India in a day time recognised institutions for all recognised full time courses of educations and training after Matriculation/Higher Sec., Pre-University Pre-Medical, Pre-Engineering, Intermediate, M.B.B.S, Part I, part II, First Degree and Master Degrees' Examinations conducted by the Board of Education or a University or a recognised Education authority.

The scholarships are open to the Nationals of India and only those students who pass any specified examination with at least 50% marks provided the income of their parents/guardians does not exceed Rs 6000/- per annum, and the scholars are not in receipt of any scholarship or stipend, the value of which is more than half the value

of loan scholarship and are not in full time employment. The value of scholarships is given below :—

Only those candidates are considered Hostel residents who reside in a recognised hostel, or due to non-availability of accommodation in hostel, in the rented accommodation, but not with the parents/guardians etc. without paying rent, others are deemed day scholars.

The scholarships once awarded at the under-graduate stage will be tenable from the start of the Post-Matriculation study to the completion of the study. The students are required to execute the Agreement bonds, regarding the repayment of loans. The repayment will start one year after the scholar has begun to earn an income which term shall not include paid practical training or three years after the termination of scholarship which ever is earlier. The repayment of



loan is to be made by monthly instalments on the following basis :—

- (i) 1/10th of income or not less than Rs. 25/- if it is less than Rs. 300/- P.M. In case of scholars who do not earn an income during any period after the repayment has fallen due, the rate of recovery for such period shall be Rs. 25/- P.M.
- (ii) 1/8th of the Income if it is between Rs. 300/- P.M. to Rs. 500/- P.M.
- (iii) 1/6th of Income if it exceeds Rs. 500/- P.M.

All loans given under the scheme are interest free but it is however, charged at 10% in respect of default in payment of any instalment.

The scholars joining the teaching profession after the completion of their studies are exempted from the payment of loan. In their case, the loan is reduced by 1/10th of their original loan for every complete year of service put in as a teacher in a recognised institution until the entire amount is wiped out. The loan scholarships are awarded to a limited number of students, strictly on merit basis on aggregate marks in accordance with quota of scholarships fixed by the Govt of India. The No. of scholarships to be awarded during the year 1979-80 has not been communicated to the Department so far, by the Govt. of India.

In order to Promote Education amongst students of Haryana Domicile belonging to approved Scheduled Castes and other Backward Classes studying in Govt. as well as recognised/affiliated Privately managed schools/colleges, the State Govt has introduced a scheme named as State Harijan (Educational) Welfare Scheme. Under this scheme the following concessions are admissible subject to means test, prescribed in the scheme.

#### School Stage

- (i) Scheduled Caste and other Backward classes students are not charged any tuition fee including (Science fee, if any) at school stage where the compulsory free Education has not been introduced.

- (ii) The above category of students will be awarded stipend in IX, X, and XIth classes in schools at the rate of Rs. 16/- per mensem.
- (iii) The admission fee for Haryana School Education Board and other examining body is reimbursable to the students taking a particular examination viz. Middle School examination Matriculation/Hr. Secondary.

The examination fee is payable only once for the above examinations.

### College Stage

At College Stage, the following concessions are available to the students belonging to other backward classes only subject to means test prescribed in the scheme.

- (i) The students belonging to Backward classes are not charged tuition fee (including Science fee if any) at college stage/ University Stage.
- (ii) These students are reimbursed their admission fee of University Examinations.
- (iii) The students belonging to backward classes are awarded stipends at the following rates :—

(2) The Govt. institutions do not charge any tuition fee from such students. The recognised privately managed institutions also don't charge any tuition fee, including Science fee in any, from such students but they receive grant-in-aid in lieu of freeship.

All the students belonging to backward classes who do not receive any benefit under the Govt. of India Post Matric Scholarship Scheme are admitted as free scholar in Govt. Technical institutions in the

courses Prescribed in the scheme and are awarded stipends at the rate of Rs. 25/- per mensem. They are also allowed refund of Examination fee, if any once for each examinations.

The other backward classes students pursuing the training Professional courses mentioned in the scheme are exempted from the payment of their tuition fees and allowed refund of Department/University examination fees only once for each examination. They are also entitled to stipends at the prescribed rates varying from Rs. 15 to 25 per mensem. Such students pursuing training Professional Courses in non-Govt. institutions are reimbursed their tuition fee in full.

All the concessions under this scheme are allowed to such students who get 33% pass marks in their preceding annual examinations.

(a) The Scheduled Caste students whose parents/guardians annual income excluding Hill Compensatory allowance is Rs. 4200/- or above will not be entitled to educational concession under the scheme at the school stage except tuition fee.

(b) The socially backward classes students whose parents/guardians income exceeds Rs. 4200/- per annum are not entitled to any concession under this scheme.

(c) Scheduled Caste children of Gazetted Officers or income Tax payers will not be eligible for any concession under this scheme even beyond the High/Higher Secondary Stage,

Under this scheme applications are invited on the prescribed form from the students concerned through their Head of the Institutions concerned.

Number of Scholarships is not fixed under this scheme. It is however, estimated that about 18000 students are likely to be benefited during the year 1979-80.

## (2) MERIT SCHOLARSHIPS FOR HARIJAN GIRLS STUDYING IN SCHOOLS,

The Harijan girl students studying in IX, X and XIIth classes are given Merit Scholarship on the basis of Middle School Examination conducted by the Haryana School Education Board at the rates given below :—

The Merit List is prepared by the Board of School Education, Haryana. The number of such Scholarships in each class is five in every District. Thus the total No. of Scholarships under this Scheme comes to 165. A sum of Rs. 45000/- is likely to be incurred during the year 1979-80.

### 3. GOVT. OF INDIA POST-MATRIC SCHOLARSHIPS TO SCHEDULED CASTE/SCHEDULED TRIBES.

Budget provision

Rs. 37 lacs. (Non Plan)

1979-80

Rs. 5 lacs. (Plan)

The scheme of Post-Matric scholarships to the scheduled castes/ and the scheduled tribes for studies in India has been sponsored by the Govt. of India with a view to provide financial assistance to the scheduled castes and scheduled tribes students studying at Post-Matriculation or Post-Secondary stage so as to enable them to complete their education. The rules and regulations of this scheme are framed by the Govt. of India. The scholarships under this scheme are awarded by the State Govt. to Haryanavi scheduled castes students studying at post-Matric stage. These are tenable for general education and other professional courses. The rates of scholarships vary from Rs 40/- to Rs. 200/- P.M. The eligible candidates are granted scholarships provided their parents/guardians income does not exceed Rs. 750/- P.M.

The total amount of budget is provided in the State Budget in the first instance. The expenditure over and above the committed expenditure is reimbursed to the State Govt. by the Govt. of India. The committed expenditure is to the tune of Rs. 37.00 lacs.

### 4. SCHEME OF POST-MATRIC SCHOLARSHIPS TO LOWER INCOME GROUPS STUDENTS FOR STUDIES IN INDIA.

Budget Provision 1979-80

Rs. 1,25,000/- (Non Plan)

The scheme of Post-Matric scholarships to scheduled castes/ scheduled tribes, Denotified Nomedic, Semi Nomedic tribes and lower income group students has been framed by the Govt. of India in order to provide financial assistance to the scheduled castes, scheduled tribes, Denotified Nomedio, Semi-Nomedio tribes and lower income group students so as to enable them to complete their education. These scholarships are given for the study of all recognised post-Matriculation courses in the recognised institutions on the basis of the poverty test within the limited available funds. These are awarded at Directorate level and the amount is sent to the Heads of the Institutions through Bank drafts. The rates of scholarships raise from Rs. 27/- to Rs. 75/- P.M.

Besides the scholars are paid enrolment/registration, tuition, games, union, library, magazine, Medical Examination and other fees compulsorily payable by the scholar to the institution or university-Board in addition studies, Tour charges and thesis/typing/printing charges.

5. AWARD OF PRE-MATRIC AND POST-MATRIC SCHOLARSHIPS TO THE CHILDREN OF THESE ENGAGED IN UNCLEAN OCCUPATION i. e. SCAVENGING OF DRY LATRINES TANNING AND FLAYING.

Budget Provision

Rs. 15000/- (Plan)  
(Post-Matric)

Rs. 72,500 (Plan)  
(Pre-Matric)

The Govt. of India started the Central sponsored scheme cited above from the year 1977-78 in order to arrest drop-outs amongst the children of Scavengers of dry Latrines, flayers and Tanners studying in Classes 6th to 10th and above. A sum of Rs. 72,500 for Pre-Matric scholarships and Rs. 15,000/- for the award of Post-Matric scholarships. These are centrally sponsored schemes.

## BROAD DETAILS ON WHICH THE ESTIMATES ARE BASED

### A. Estimates of Receipts

The income of the Department accrues from the following sources :—

1. Admission fees levied in Govt, K. G. Nursery, Primary and Middle schools,
2. Fees levied in Government Secondary Schools.
3. Fees levied from Govt. JBT Institutions;
4. Fees levied in Govt. Arts Colleges and Professional Colleges,
5. Miscellaneous Receipts.

Miscellaneous receipts comprise of the under mentioned items:—

- (1) Examination Fees
- (2) Fines
- (3) Fees for issue of duplicate certificate
- (4) Hostal fees
- (5) Fees for approving library, Prize and Text Books.
- (6) Electricity fees (charges from boarders)
- (7) Receipt on account of unspent balance of Govt. grants.
- (8) Receipt from Royalty and Text Books.
- (9) Income from Agriculture Farms.
- (10) Recoveries of over-payments.
- (11) Collection of payment for services rendered.

About the criterion which are usually followed in compiling the estimates of the above primary units of appropriation the position is explained hereunder in seriatim:—

### 1. Pay and Allowances

It will be seen from the data given in Para-I above that 77.9% Budget provision is earmarked to meet expenditure on pay & allowances of the staff. In framing the estimates for sanctioned establishment, whether permanent or temporary, the provision for Pay & Allowances is made on the basis of nominal rolls. Provision for new posts is made at the minimum of the time scales except in cases where a higher start is given according to standing orders of Government.

### 2. Travel Expenses

Major portion of expenditure on Travel Expenses is incurred on account of Transfers and (ii) Inspection of School/Colleges in the State. The Budget provision on account of the later is made, keeping in view jurisdiction of inspecting officer and frequency of tours.

### 3. Contingent Expenditure

This primary unit of appropriation consists of following components viz :—

- (1) Office Expenses
- (2) Material & Supplies
- (3) Wages
- (4) Rent, Rate & Taxes
- (5) Other charges
- (6) Charged expenditure

#### Office Expenses

The grant for office expenses is fixed for all institutions/offices according to their needs individually. The grant is meant to meet the expenditure for running an office such as, furniture, postage, purchase and maintenance of office machines equipment, liveries, hot and cold whether charges (excluding wages of the Staff) telephone, electricity and water charges stationery, printing of forms, purchase & maintenance of staff cars & other vehicles for office use.

#### Material & Supplies

All contingent expenditure for running an institution, such as furniture, science equipment & material for Agriculture farms, purchase of books, charts and journals.

#### Wages

Wages of labourers, if any, engaged out of contingencies i.e. part-time employees employed in institutions/offices.

### **Rent Rate & Taxes**

Payment of rent for hired buildings, municipal Rates & Taxes etc. It also includes lease charges for land.

### **Other Charges**

A residuary head. This will also include rewards and Prizes.

### **4. Grant—In—Aid**

The position regarding anticipated expenditure on grant-in-aid is assessed keeping in view the actual of preceding year. Unsettled claims relating to the previous year and interest of Education wherever, it is anticipated to suffer due to financial difficulties faced by private Semi-Govt. organization having arrangements of imparting education are also taken into account. Having due regard to the cause of Education, the Govt. have enhanced the grants of private institutions imparting college Education to the extent of 75% of their deficit for which necessary funds have been included in the current year's budget.

### **5. Scholarships**

The existing schemes relating to which the expenditure is chargeable to primary unit of appropriation given as under :—

- (i) Merit Scholarships
- (ii) National Scholarships
- (iii) Award of Scholarships to students studying sanskrit.
- (iv) Award of Scholarship in secondary schools.

The estimates are based according to number of Scholarships fixed under rules allotted by the Govt. of India in respect of items at Sr. No. (ii) and (iii).

### **6. Charged Expenditure**

The provision under this unit is made in the Budget on adhoc basis to meet decretal charges during the year.

### Recommendations/observations of the Committee.

16. The Committee was not satisfied with the statement of the Departmental representatives during the course of oral examination in respect of the appointment of D.P.I. from I.A.S. cadre

**Appointment of  
D. P. I.**

The Committee is therefore of the opinion that the Education Department should be headed by an educationist instead of an Officer drawn from the Indian Administrative Service, who can give a proper direction to the formulation of the education policy on correct lines and look after the administration of the Education Department in a better way on the basis of his mature practical experience in the field of education.

17. During the course of oral examination the departmental representative stated that in view of the heavy expenditure involved in the scheme and non availability of adequate number of doctors in the State it is not possible for the Department to get every student of all the schools in the State medically examined once in a year. The Committee was of the view that the Government should make available to the Department all the necessary resources for implementation of such a good scheme.

The Committee, therefore, recommends that the students must be medically examined at least once during a session.

18. The departmental representatives explained the policy of transfers and postings of the teachers in the State. The Committee was of the opinion that the present policy is not beneficial for all the teachers and requires modification and should be evolved in such a manner that every teacher may be able to get the benefit of house rent allowance payable to the employees working in cities during the span of one's service period.

The committee, therefore, recommends that the decision of an earlier Committee regarding effecting transfers after a lapse of 5 years should be strictly adhered to and further recommends that those teachers and master who are drawing house rent within a radius of 5-8 kilometres of a town must be transferred from that place after due period to some rural areas beyond a distance of 10 kilometres from a town.

19. From the written as well as the oral statement of the Department, Committee came to know that the Annual Reports of the department are not presented to the Government after the end of each financial year and the matter of printing of the Reports is too much delayed. The Committee takes a serious view of this slackness on the part of the Department. The Department should adopt measures to avoid such delays in future.

**Printing of  
Reports.**

The Committee, therefore, recommends that the annual administrative Reports must be completed and submitted to the Government during the succeeding year by all means.

20. During the course of oral examination the departmental representatives stated that no such coordination Committee exists at district level to decide the cases of transfers of the teachers. The Committee stressed that to avoid inconvenience caused to the teachers and the students due to their haphazard transfers a coordination Committee is required to be set up at the district level so that education of the students may not suffer on account of transfers of teachers. The Committee desires that concrete steps should be taken in this direction by the Government.

The Committee further recommends that there must be a co-ordination Committee at the district level for deciding the transfers of masters and teachers and it must consist of D.E.O., S.D.E.O. and B.E.O.

21. The Committee was not satisfied with the statement of the departmental representative regarding the N.S.S. Schemes | Schemes as being implemented at present. The Committee was of the view that this scheme should also be introduced in the small villages for universal benefit.

The Committee further recommends that the small villages which may be ready to cooperate with N.S.S. Scheme should also be adopted under this Scheme.

22. During the oral examination the departmental representative stated that Scout movement is not working upto the satisfaction these days. The Committee desired that scouting should be conscribed in the schools because this is an essential subject for proper development of a student as a good citizen.

The Committee further recommends that enrolment of scouts in the educational institutions should be popularised and encouraged and earnest efforts should be made to enrol the maximum number of students both boys and girls as scouts and guides.

23. During the oral examination of the departmental representatives the Committee felt that at present the syllabus of school going children is so heavy that seems to be unmanageable in a proper way and is difficult for the students to cope with for their academic development. Such a heavy syllabus is an impediment in education and immediate steps are required to be taken by the Government to reduce the syllabus in size and load.

As the present syllabi of students is very bulky the Committee recommends that speedy steps may be taken to reasonably reduce it

so that the students do not feel its burden and could conveniently cope with their studies and get real benefit out of it.

24. During the course of oral examination after hearing the evidence of the departmental representatives the Committee came to the conclusion that work of construction and repairs of the school buildings was slow though the funds had already been allocated for the purpose. The Government should take all care to speed up its efforts in this direction. The loopholes if any, should be removed immediately.

**Construction and repairs of School buildings**

The Committee recommends that the repair work of all such middle, High and Higher Secondary schools which have been taken over by the Government should be completed at the earliest and where the buildings are under construction or are to be constructed, the same should be completed on priority basis.

25. During the course of oral examination the Committee cited many an instances where the condition of the private buildings used for schools on rent is dilapidated. The Committee was of the view that all such buildings should be acquired with immediate effect and got repaired on emergent basis because the owners of such buildings are taking no interest for proper maintenance of such buildings. It is essential so that such schools could be run properly after undertaking the necessary repairs.

**Private Buildings rented for schools**

26. The departmental representative stated that the Scholarships are given to students on the basis of a prescribed limit of income of their parents. The Committee felt that in this way the promising students who top the merit lists were deprived of this benefit which was a great injustice to such students.

**Scholarships Awarded to Students**

The Committee, therefore, recommends that the students who come on the merit list, should not be deprived of scholarships for the reason that the income of their parents is higher than the limit prescribed by the Department. There should be no income limit for merit scholarships.

27. The Committee feel that the Government should make the procedure of payment easy so that the grants in aid can be paid to the schools and Colleges well in time to avoid hardships being faced by the staff at present. The Committee also showed concern over the delay in the finalization of the case in respect of providing grants in aid to meet the 75% deficit of funds of such schools and Colleges. The Committee recommend that this case should be decided by the Government immediately.

**Grants paid to privately managed Schools and Colleges.**

The Committee further recommend that the Government may drop the proposal for increasing tuition fees to lessen the burden on exchequer to meet such deficits in schools and Colleges Fund.

28. The departmental representatives explained the details in respect of N.C.C. training imparted to the student and stated that this training cannot be made part of the curriculum. The Committee was of the view that this training should be given to all the students and in this way they will become disciplined like the students of Sainik schools.

**N.C.C. Training imparted to Students.**

The Committee, therefore, recommend that the Government should pay its attention to this suggestion keeping in view all the aspects of providing N.C.C. training to all the students of schools and Colleges in the State.

The Committee further recommend that the rate of refreshment per head provided to the trainees should be revised as the present rate of 60 paise per head per parade is most inadequate for refreshment due to increase in price level.

29. The Committee was not satisfied with the reasons explained by the departmental representatives during the oral examination in respect of too much delay in pension cases of retired teachers. The Committee was of the view that the Department should take necessary steps to keep the records of all its employees in order so that such kind of delay in pension cases may not occur in future.

**Delay in settlement of Pension cases.**

The Committee recommend that the Government should take necessary steps to expedite the settlement of pending pension cases and adopt suitable measures so that office inefficiency may not cause unnecessary harassment to the retiring officials.

The Committee further recommend that the pending cases in regard to "fixation of seniority" should also be finally settled expeditiously. Such type of lacuna should be removed from the working of office administration.



# IRRIGATION DEPARTMENT

## 30. THE ORGANISATION OF THE DEPARTMENT AND ITS SUBORDINATE OFFICES

The State Irrigation Department is under the charge of an Engineer-in-Chief, who is head of the department. He has under his charge amongst other subjects, establishment (gazetted), Planning, Budgeting monitoring Inter-State disputes and policy matters.

There are six Chief Engineers Incharge of important projects and running and maintenance of canals. Duties assigned to the Chief Engineers are as under :—

### (i) Chief Engineer/SYL.

He is incharge of construction of Sutlej Link Yamuna Link, Project a canal with a capacity of 7,500 Cs. He has under his charge 5 Superintending Engineers, while three are incharge of construction in the field, one Superintending Engineer is incharge of project circle and other incharge of remodelling. Each circle has four Executive Engineers and other connected subordinate staff. Besides this he is incharge of central Design & P.A.C.

### (ii) Chief Engineer/Running Canals

He is incharge of maintenance and running of all the existing irrigation canal systems in Haryana. He has under his charge 5 Superintending Engineers who have under their charge 3 Executive Engineers each. In addition he is incharge of regulation work under Superintending Engineer/Regulation. The Executive Engineer have under their charge engineering staff viz sub divisional officers and Sectional Officers as well as Revenue staff comprising of Deputy Collectors, Zilladars, and Irrigation Revenue Booking Clerks.

### (iii) Chief Engineer Drainage I.

He is incharge of Drainage Project. He has under his charge 5 Superintending Engineers, who in turn have under them about 4 Executive Engineers in each Circle. Out of these three Superintending Engineers are engaged on drainage works one on procurement & the fifth incharge of Hanthni Kund Barrage. The Executive Engineers have under their charge 3—4 Sub Divisional Officers. In addition to this Non Gazetted Staff is also under his control.

### (iv) Chief Engineer/Drainage II.

He is incharge of Drainage Projects. He has under his charge 5 Superintending Engineers. Who in turn have under them about 4 Executive Engineers in each circle. The Executive Engineers have under their charge 3-4 Sub Divisional Officers. While three Superintending Engineers are engaged on exclusively for flood work, one Superintending Engineer is incharge of Gurgaon Canal & fifth in Design.

**(v) Chief Engineer/Project.**

He is incharge of modernisation of Irrigation Channels in Haryana under world Bank Programme. He has under his charge 5 Superintending Engineers each having attached to it about 4 Executive Engineers. Each Executive Engineer has 4 Sub Divisional Officers under their control. In addition work of inter-state dispute with Superintending Engineer/Planning and monitoring work under Superintending Engineer/monitoring is processed through Chief Engineer/Project.

**(vi) Chief Engineer/JLN.**

He is incharge of construction of lift irrigation projects in Haryana. He has under his charge 6 Superintending Engineers each having attached to it about 4 Executive Engineers. Each Executive Engineer have 3-4 Sub Divisions.

**(vii) Head Office Establishment.**

A statement showing the Organisation in the Irrigation Department is enclosed.

The Engineer-in-Chief and the 6 Chief Engineers are assisted in their work by the following officers in the Head Office.

**(a) Superintending Engineer Planning & Executive Engineer Planning.**

They deal with the distribution of assets and liabilities of earst-while Punjab State inter state disputes of works, allocation of budget grant and Planning of irrigation projects.

**(b) Executive Engineer/Canals.**

He assists the Chief Engineer/Canals in all matters relating to Canal Administration

**(c) Executive Engineer/Regulation.**

He assists the Chief Engineers in all cases dealing with regulation of supplies in the canal system of W.J.C. in the State.

**(d) Executive Engineers/General & Revenue.**

He assists the Chief Engineer/Canals in revenue matters and other general type of works.

**(e) Executive Engineers/Floods.**

They assists the Chief Engineers Drainage in matters relating to construction maintenance of flood control and drainage works etc.

**(f) Executive Engineer/Projects.**

He assists the Chief Engineer/JLN with all the work relating to his administration.

**(g) Executive Engineer/Lining.**

He assists the Chief Engineer/Project with the work relating to Lining of Channels in Haryana.

**(h) Executive Engineer/Groundwater.**

He assists Superintending Engineer personnel MITC/Projects and Regulation in the matters dealing with the disciplinary cases of MITC personnel and training and other works programme.

**(i) Executive Engineer/S.Y.L.(W)**

He assists the Chief Engineer/SYL in matters relating to his administration.

**(j) Administrative Officer.**

He deals with all cases of establishment relating to Irrigation Department (Except Head Office Estt.)

**(k) Establishment Officer.**

The Non-Gazetted establishment is dealt by the Estt. Officer.

**(l) Registrar**

He deals with all cases of establishment relating to Head Office and also acts as Drawing and Disbursing Officer.

**(m) Officer on Special Duty.**

He deals with all cases relating to accounts, PWD Misc. Advances, Audit/PAC paras for the department as a whole.

### 31. THE FUNCTIONS OF THE DEPARTMENT AND ITS SUBORDINATE OFFICES

The Irrigation Department is responsible for the efficient maintenance and running of the irrigation canal system and construction of various irrigation projects in the state. The department also maintains various flood control and Drainage Works and undertakes execution of schemes for control of floods and construction of river protection works.

Construction and maintenance of deep tubewells is now being looked after by H.S.M.T.C.

Engineer-in-Chief is the head of the Department who in turn is responsible to the Commissioner and Secretary to Govt. Haryana, Irrigation Department.

The administrative unit of the department is the Circle, which is under the charge of a Superintending Engineer. The executive unit of the department is a Division, which is under the charge of an Executive Engineer. Division is further divided into Sub-Divisions, which in turn have staff under them for supervision and execution of works.

### 32. BROAD DETAILS ON WHICH THE ESTIMATES ARE BASED

The budget estimates are based on detailed projects for execution of works and the programme for execution of these schemes as drawn up for the current year. As regards, maintenance works, the budget estimates are based on actual requirement of establishment already in position and estimate of maintenance expenditure as assessed keeping in view the requirement of ut-most economy in the departmental expenditure.

### 33. VOLUME OF WORK IN THE DEPARTMENT AND ITS SUB-ORDINATE OFFICES COVERING THE PERIOD OF ESTIMATES AND GIVING FOR THE PURPOSE OF COMPARISON CORRESPONDING FIGURES OF THE PAST THREE YEARS

The construction work being undertaken in the State in respect of irrigation projects has been increasing over the years as per comparison depicted below :—

**35. REASONS FOR VARIATIONS, IF ANY, BETWEEN THE ACTUALS OF THE PAST THREE YEARS AND THE CURRENT ESTIMATES**

The variations under the main heads are explained as under :—

**(i) Major and Medium Irrigation Schemes**

The tempo of execution of various major and medium irrigation schemes has been increased over the years. It is now proposed to incur an expenditure of Rs. 5788 lakhs on execution of these schemes during year 1979-80. The expenditure on these schemes was partially less in the preceding years,

**(ii) Flood Control and Drainage schemes**

As already explained, the State has accepted execution of a master Plan for flood control & Drainage Schemes estimated to cost of Rs. 138 crores. It is now proposed to keep up the accelerated tempo on execution of flood control & drainage schemes in the next 5 years. Whereas the expenditure in 1974-75 and 1975-76 was about Rs. 2 crores. The expenditure during 1976-77 was Rs. 3.56 crores. The budget estimates for the year 1977-78 account for an expenditure of Rs. 9.95 crores against which a sum of Rs. 10.38 crores was spent, and expenditure for 1978-79 is Rs. 26.35 crores. Budget for 1979-80 is Rs. 20 crores.

**(iii) Maintenance Works**

There is increase in the maintenance expenditure on account of the following :—

- (i) Grant of A.D.A. to the Estt.
- (ii) Increase in prices of material and labour, which has reflected in execution of works :—
- (iii) The more and more channels of the lift irrigation schemes are being commissioned, which has resulted in increase in running of these lift irrigation schemes ;
- (vi) Additional augmentation tubewells are being installed in the state, which are resulting in increased running cost.

36. During the course of oral examination the departmental representatives gave detailed information regarding the steps taken by the Government to control the floods constructing bundhs and reservoirs on the various rivers and rivulets passing through the State. The Committee, however stressed that the Tangri and Markanda rivulets during the rainy seasons create great-havoc in the area. The steps taken by the Government to control the flood waters of these two rivulets are not sufficient. The Government should also see that these rivulets may not cause hell in their areas in future.

**Controlling Rivers/Rivulets**

The Committee recommends that bundhs on Tangri and Markanda rivulets be constructed on priority basis so that the rainy water could be made available for irrigation purpose.

37. It was brought to the notice of the Committee by the departmental representatives during the course of oral examination that the department has so many projects in hand that sufficient money is required for completion of the same in time. These projects are augmenting the irrigation and power facilities for the farmers in particular and people of the State in general. But it is not done according to the programme sketched by the department because the cuts are effected in the plan and non-plan expenditures to be made by the department for completing the various projects already started and to be started to augment the supply of water and power to the needy farmers.

**Lack of Availability of funds (Plan/non-Plan) for Development of Projects**

The Committee took a serious view of this lag on the part of the Government and desired that Government should not ignore the importance of such projects run by the department. The funds in adequate proportion should be allocated to the department on priority basis.

The Committee recommends that Government should pay its full attention towards controlling the floods and adequate amount be allocated for the same and the work started for this purpose should be speedily completed.

The Committee further recommends that there should be no cut on plan expenditure as it was stated by the officers of the department that they received only 16 crores whereas a provision of Rs. 25 crores was made in the plan in the first phase for controlling the floods in Haryana State in the master plan.

38. During the course of oral examination the departmental representatives stated that there are proposals for spurs and studs on the Yamuna river to protect the cultivable areas of the State but the work has not been started so far. The Committee was of the view that action should be taken with immediate effect to start construction of spurs and studs on the Yamuna river.

**Spurs and Studs on the Yamuna River.**



The Committee, therefore, recommends that the spurs and studs as proposed on the Yamuna river for protecting the cultivable areas be completed on top priority basis.

39. The Committee was not convinced with the details of action being taken by the department for controlling the flood water of Yamuna river as explained by the departmental representatives. The Committee was of the opinion that the works taken in hand by the department are meagre and some additional schemes should also be taken in hand so that the Haryana side may be protected from the havoc of floods of Yamuna river.

**Controlling Floods of Yamuna River.**

The Committee, therefore, recommends that a bandh be constructed from village Chogamma, Distt. Karnal to Kalanaur, Distt. Ambala on river Yamuna so that the Haryana side may be protected from the havoc of floods.

40. During the course of oral examination the Committee expressed the difficulties being faced by the farmers in the Karnal district because the water level there has gone down in the district because of installation of deep and shallow tubewells along with the augmentation canal. The farmers have to bear heavy expenses for re-boring of tubewells. To save the farmers from such extra expenses the Govt. should find ways and means to stop installation of deep and shallow tubewells along with the augmentation canal.

**Deep and Shallow Tubewells Installed along with Augmentation Canal.**

41. The departmental representatives during the course of oral examination explained the scheme for lining of canals and water channels in the State to check seepage and wastage of canal waters. The departmental representatives gave details of various works of lining of canals started by the department. The Committee recommends to take in hand lining of W.J.C. from Dadupur to Yamuna Nagar in addition to the work already in progress on that canal.

**Lining of Canals and Water Channels in the State.**

The Committee, therefore, recommends that lining of W.J.C. from Dadupur to Yamuna Nagar be taken on priority basis so that the water of the Hydrel channel which is under construction from Hathnikund to Dadupur be taken in the W.J.C. and no second channel from Dadupur to Yamuna Nagar need be constructed which will save considerable labour and expenses.

#### GENERAL OBSERVATION

42. The Committee after oral examination of the departmental representatives came to the conclusion that various useful projects/works are in progress in the State but as explained by the departmental representatives the speed of progress was slow and in some cases the works have been ignored due to paucity of funds. There are certain

schemes which are still to see the light of the day. The reasons for delays in completing those projects are non-availability of funds in time which create hinderances in the alround progress of the State.

The Committee, therefore, recommends that in view of the importance of projects taken in hand by the department the Government should make available sufficient funds so that these projects may be completed in time for the benefit of the State as a whole.
