(Brief record of the proceedings of the meeting of the Haryana Vidhan Sabha held on Thursday, the 12th March, 2015 from 10.00 A.M. to 3.10 P.M.)

II. INTIMATION REGARDING ABSENCE

(i) The Speaker informed the House that he had received an intimation from Sh Om Parkash Dhankar, Agriculture Minister in which he has expressed his inability to attend the sittings of the House from 12th and 13th March, 2015 as he has to attend the Agri-Leadership Summit to be held in Gurgaon and moved that permission for leave of absence be granted to the Hon'ble Minister.

The motion was put and carried.

(ii) The Speaker informed the House that he had received an intimation from Sh. Bikarm Singh Yadav, Minister of State for Cooperation, Haryana in which he has expressed his inability to attend the sitting of the House on 13th March, 2015 as he has to inaugurate the Agri-Leadership summit to be held in Gurgaon and moved that permission for leave of absence be granted to the Hon'ble Minister.
