V BUDGET FOR THE YEAR 2008-2009.

General discussion on the Budget Estimates for the year 2008-2009.

Dr. Sushil Indora, a member from the Indian National Lok Dal, spoke for 89 minutes.

Smt. Sumita Singh, Shri Bhupinder Chaudhry and Shri Amir Chand Makkar, members from the Treasury Benches, spoke for 26, 13 and 12 minutes respectively.

Shri Ram Kumar Gautam, member from the Bhartiya Janata Party, spoke for 34 minutes and was still in possession of the House, when it was adjourned.

VI NAMING OF MEMBER.

During the discussion on the Budget Estimates for the year 2008-2009, Shri Balwant Singh Sadhaura, a member of the Indian National Lok Dal and other members of his party, started speaking without permission of the Speaker. Even they came to the well of the House and did not resume their seats, inspite of having been repeatedly asked by the Speaker to do so. Thereafter, Shri Balwant Singh Sadhaura was named for his grossly disorderly conduct and asked him to withdraw from the House. The member withdrew from the House.

VII WALK-OUTS

(i) During the question hour, all the members of the Indian National Lok Dal present in the House staged a walk-out as a protest against not being given time to speak.

(ii) During the discussion on the Budget Estimates for the year 2008-2009, all the members of the Indian National Lok Dal present in the House, staged a walk out as a protest against naming of Shri Balwant Singh Sadhaura.

VIII PERSONAL EXPLANATION.

During the discussion on the Budget Estimates for the year 2008-2009, the Chief Minister gave a personal explanation with regard to certain remarks made against him by Dr. Sushil Indora.

IX EXTENSION OF SITTING.

The Speaker, with the sense of the House, extended the time of the sitting at 1.29 P.M. for 10 minutes.

I.G. Sher Singh, a member from the Panel of Chairpersons occupied the Chair from 12.17 P.M. to 1.08 P.M.
