To Construct the Road

- 440. Shri Neeraj Sharma, M.L.A. :** Will the Chief Minister be pleased to state—
- (a) whether it is fact that the tender of constructing road leading from Whirlpool Chowk to Saran Chowk has been released to Brij Goyal Construction by the HSIIDC and thereafter same tender has been given to some other company with less amount of Rs. 41.05 crore by HSVP in regard to the above said road and some other roads;
 - (b) whether it is also a fact that Brij Goyal Construction company has been taken stay orders from the Hon'ble High Court due to which the said road has not been constructed so far; and
 - (c) whether it is also a fact that the Brij Goyal Construction company had assured in writing to withdraw the case so that the road may be constructed ?

To Start Construction Work of New Grain Market

- (ii) village Katwal bus stop to Gohana Kharkhoda Road to Kakana Bhadri via Lath and Jauli;
 - (iii) Tihar Khurd to Tihar Kalan;
 - (iv) Gohana to Sonapat road portion upto village Bidhal; and
- (b) if so, the time by which these roads are likely to be repaired?

Construction of Road

- (a) whether it is a fact that a complaint has been given by Shri Devi Charan Sharma Pardhan and all residents of Rajeev Colony, Banke Bihari Colony Gali no.-1-7, vide letter no.-LFA/2019/1524 dated 27/09/2019 to the Grievances Committee, Faridabad but no action has been taken by the Government on said complaint till to date ; and
- (b) if so, the time by which the main road of Banke Bihari Mandir at Rajeev Colony is likely to be constructed after solving the abovesaid complaint?
