## **Report**

The Subject Committee on Education, Technical Education Vocational Education, Medical Education and Health Services for the year 2021-2022 consisting of nine members and two Special Invitees were nominated by the Hon'ble Speaker, Haryana Vidhan Sabha on under Rule 279-A of the Rules of Procedure & Conduct of Business in the Haryana Legislative Assembly.

The Functions of the Committee are as under:-

- (i) to scrutinize the demands for grants;
- (ii) to examine the working of these departments and to suggest measures for improvements in administration and in different programmes/schemes/projects;
- (iii) to examine legislation;
- (iv) to advice Government on a question of policy or legislation on which Government may consult a Committee;
- (v) to discuss generally and formulate view on-
  - (a) State's Five Year Plan Programme relating to these departments and their implementation;
  - (b) Report of Public Undertaking under these department;
  - (c) Reports of any statutory or other body, including any Commission of Inquiry, which are laid before the House relating to these departments and
  - (d) Annual Performances Reports of these Departments.

The Subject Committee held 37 sittings during the year 2021-2022 (till finalization of the Report)

10. Documents pertaining to current State's five years plan programme relating to Department and their implantation.
11. Estimate submitted by the departments from different heads.
12. Amount sanctioned for departments.
13. Actual Amount Received by departments.
14. Utilization of money by these departments.

## BRIEF NOTE

### SCHOLARSHIP SCHEMES WITH EXPENDITURE.

#### 1. **CONSOLIDATED STIPEND SCHEME FOR THE WELFARE OF SCHEDULED CASTE STUDENTS PURSUING HIGHER EDUCATION IN GOVT. COLLEGES OF HARYANA.**

The scheme was introduced by the Govt. of Haryana in the year 2008-09. Under this scheme a stipend of Rs. 1000/- P.M for twelve months and an additional amount of Rs. 50.0/- P.M for twelve months to those S.C Students who are availing hostel facility has been given through electronic transaction . The Nodal Officer and staff will be paid honorarium in a year maximum of Rs. 4000/- and 2000/- respectively. The scheme covers only the students in Govt. College of Haryana.

**Process of payment:** The amount of stipend shall be transferred through PFMS by Head Quarter in two half yearly installments of Rs. 6000/- each in the first week of September 2020 and January 2021. The Principals of the Colleges will forward the verified data of the students on ERP and send it to the Headquarter, thereafter the amount will transferred to the beneficiary in aadhaar link bank account through PFMS.

**Estimate of Scheme Yearly Expenditure: 45 Crore**

#### 2. **PROVIDING BOOKS TO SC STUDENTS OF GOVT. COLLEGES.**

In the year 2008-09 the Govt. of Haryana introduced this scheme for the welfare of SC students. Under this scheme an amount of Rs. 2000/- P.A. for purchasing books, is given to the deserving SC students. The payment has been made through electronic transaction. The scheme covers only the students in Govt. College of Haryana.

**Process of payment:** The amount of books shall be transferred through PFMS by Head Quarter in yearly installment of Rs. 2000/- in September 2020. The Principals of the Colleges will forward the verified data of the students on ERP and send it to the Headquarter, thereafter the amount will transferred to the beneficiary in aadhaar link bank account through PFMS.

**Estimate of Scheme Yearly Expenditure: 8 Crore**

#### 3. **A SCHEME INTRODUCED BY THE HARYANA GOVT. FOR MERIT SCHOLARSHIP TO UNDER GRADUATE GIRL STUDENTS**

The State Government introduced this Scheme on plan side during the financial year 2005-06. The main objective of the scheme is to enable meritorious girl students of Haryana to pursue higher education. It has been instituted in order to attain the national goal in making all our efforts to provide good education and bringing women in the mainstream of the society. The 10 topper girl students who after passing 10+2 class with at least 60% marks are studying in any Govt. institution pursuing general degree courses are awarded under the scheme. The amount of the scholarship awarded has been Rs. 3000/- per college per student annually. This scheme is renewed upto TDC III.

**Estimate of Scheme Yearly Expenditure: 50 Lacs.**

#### **4. HARYANA STATE (MERITORIOUS INCENTIVE SCHEME) SCHOLARSHIP SCHEME**

The State Government has introduced a scheme on plan side during the financial year 2005-06. The main objective of the scheme is to encourage excellence in academics and overall development of the students. Under the scheme the male students (general category), female students (general category) and both male and female students (S.C. category) are given fixed annual scholarship based on their position/performance in Annual University Examination, in both graduate and post graduate classes at college level. The students who stand first in the Merit have been given Rs. 5000/- p.a., Second Rs. 3000/- p.a. Third 2000/- p.a. The scheme is only for Govt. Colleges.

**Estimate of Scheme Yearly Expenditure: 60 Lacs.**

#### **5. HARYANA STATE MERITORIOUS INCENTIVE SCHEME FOR THE STUDENTS WHO ATTAIN MERIT POSITION IN CBSE ANNUAL EXAMS.**

The objective of the Scheme is to encourage the Meritorious Students who attain Top position in CBSE annual exams, by giving them a substantial amount as a motivating incentive. It has been instituted by Govt. of Haryana in order to encourage excellence in academics and overall development of the students. Under this Scheme two students (one boy & one girl student) are given annual Incentive based on their Merit position/performance in Haryana State in annual examination of 10<sup>th</sup> and 12<sup>th</sup> of CBSE every year. Under this scheme the toppers (1 Girl and 1 Boy) of 10<sup>th</sup> and 12<sup>th</sup> are awarded the actual fees paid by him /her upto Rs. 25000/- and Rs. 1,00,000/- p.a. respectively. It is also a renewal scheme.

**Estimate of Scheme Yearly Expenditure: 10 lacs.**

#### **6. STIPEND SCHEME FOR THE WELFARE OF GRAND CHILDREN OF FREEDOM FIGHTERS.**

In this scheme Rs.2000/- P.A. for books and a stipend of Rs. 1000/- per month for twelve months are given to all such students. This scheme covers the students of Govt./ Non-Govt. Aided Colleges of Haryana.

**Process of payment:** The payment will be made by the electronic transaction. The Principal of the concerned institution Govt. / Aided College will be responsible for opening of Bank account of such students in a Nationalized Bank which is having a provision of electronic transaction. The Directorate will transfer the amount online to the Govt. College and through EPS to aided colleges. Principal will transfer the amount into the Bank accounts of the eligible students and provide the APR immediately to the Directorate.

**Estimate of Scheme Yearly Expenditure: 5 Lacs**

#### **7. STATE MERIT SCHOLARSHIP**

The Govt of Haryana has introduced this scheme to motivate the meritorious students of Haryana. This scheme provides an award to the students of Govt./



Non-Govt. Colleges on the basis of Board/University merit. Detail of Rate of scholarship is as under:-

At Graduate level	300/- per month for the whole year
At Postgraduate level	450/- per month for the whole year

This scheme has benefited 500 students on the basis of 10+2 examination and 205 students on the basis of TDC-III university examination. This is a renewal scheme.

**Estimate of Scheme Yearly Expenditure: 30 Lacs**

#### **8. LOWER INCOME GROUP (NON-PLAN)**

This scheme was formulated by the state Govt with the aim of reaching out to the economically weaker sections of the society i.e. low income group students who without the financial support provided by the Government would not be in a position to pursue higher studies. The students whose parents/guardian's annual income limit is Rs. 12,000/- or less than it are covered in this scheme. Under this scheme a stipend of Rs. 27/- P.M., Tuition Fees, Exam Fees and other funds is given to the students.

- iii) For Principals to be appointed in B.Ed. colleges, equal weightage is to be given to percentage in M.A./M.Sc./M.Com and M.Ed.
- iv) For SC candidates the weightage of marks shall be given at par on acquiring marks as per the above criteria.

**THE SPOT VISIT/INSPECTION OF GOVERNMENT GIRLS COLLEGE IN SECTOR-12, SONEPAT BY THE COMMITTEE.**

The Committee visited newly under –construction Government Girls College Sector-12, Sonapat and inspected the work College Building. The total expenditure of this College building will be Rs. 1965.85 Lac and it is spread in about 10.98 Acres land. S.E. PWD (B&R), Sonapat assured that the construction work of Government Girls College Sector-12, Sonapat will be completed upto 31<sup>st</sup> January, 2022. The Chairperson of the Committee (Smt. Seema Trikha, MLA) recommended that a Girls Hostel and a play ground should be made available for girls' students. The concerned officers told that the if land is available then they are ready to construct Girls Hostel and play ground there. The Committee directed Deputy Commissioner, Sonapat and S.E. PWD (B&R), Sonapat that they should make efforts for the land for Girls Hostel and play ground & inform the Committee accordingly action taken thereon.

**THE SPOT VISIT/INSPECTION AND DISCUSSION WITH DIRECTED, HIGHER EDUCATION & VICE CHANCELLOR, BHAGAT PHOOL SINGH MAHILA VISHWAVIDYALAYA, SONEPAT.**

The Committee visited/meeting with the Director, Higher Education, Vice Chancellor and Registrar, Bhagat Phool Singh Mahila Vishwavidyalaya, Khanpur Kalan, Sonapat. The Vice Chancellor told that there is total number of girls students are 5500 in this University and six more colleges are affiliated with our University. The matter of teacher's salary was also discussed in meeting then the Director, Higher Education assured that the matter of teacher's salary will be solved. The Chairperson of the Committee pointed out the shortage of teaching staff in Bhagat Phool Singh Mahila Vishwavidyalaya, Khanpur Kalan, Sonapat and its concerned Colleges. The Director, Higher Education assured the Committee that this matter also will be checked & solved. After that the Chairperson of the Committee asked the Vice Chancellor about the placement of the students who have completed their studies from this Vishwavidyalaya and also desired that the record in this regarding should be sent to the Committee. The Committee remembered Amar Shaheed Bhagat Phool Singh for his contribution toward uplifting of Girls education in society. The Chairperson of the Committee wished that Bhagat Phool Singh Mahila Vishwavidyalaya, Khanpur Kalan, Sonapat may be one of the significant University in India.

## Higher Education Department

### Observations/Recommendations of the Committee

- 1) During the course of oral examination the Committee observed that the Girls students are facing problems in reaching their Universities/Colleges and come back to home. There is great problem for rural area Girls students. The Committee discussed about the Government policy under which free traveling facilities to be provided to Girls Students in the State within 17 Districts in Haryana. The representatives of the concerned Departments as Principal Secretary, Higher Education Department, Principal Secretary, Transport Department and the Director, Transport Department of Haryana attended in oral examination of the Committee.

Therefore, the Committee strongly recommended that the free traveling facilities must be provided to the Girls students who are studying in Colleges and Universities in the State. The Committee also directed the Higher Education Department that the possible arrangements should be made to provide free traveling facilities for all the studying girls students in the Colleges and Universities not only in the 17 Districts but also in the whole state. The Chairperson of the Committee directed that there should be some coordination at local level in which Deputy Commissioner, District General Manager, Haryana Roadways including all Government College Principals.

- 2) The Committee discussed with the Higher Education Department in details about the large number of vacant posts of Principals and Assistants Professors in Universities and Government Colleges. The Committee found that in 107 Government Colleges have not their own regular Principals out of 172 Colleges. During the oral examination the Committee observed that the above 2500 posts of Assistant Professors are lying vacant in the Government Colleges. There is great shortage of non-teaching staff also in the Universities and Government Colleges.

The Education Committee recommended that the Higher Education Department must take necessary steps to fill the number of vacant posts of Principals, Assistants Professors and non-teaching staff in Universities and Government Colleges.

- 3) During the oral examination of the Higher Education Department the Committee pointed out that there is a variation in the Stipends which is to be given to the Scheduled Caste Students in the Government Colleges. The Principal Secretary, Higher Education Department admitted that there is backlog at least 20 Carore rupees in Stipend of Scheduled Casts for the Government Colleges.

The Committee recommended that this matter is concerned with poor students so the stipend should be given on time. The backlog in Stipend of Scheduled Caste Students should be completed without any further delay and submit the action taken report to the committee.

- 4) The Committee observed that the construction work of the Government College Buildings are pending in the state and this matter was discussed with Principal Secretary, Higher Education Department and Additional Chief Secretary, PWD (B & R) during the oral examination of the Committee.

The Committee recommended that the construction work of the Government College Buildings should be completed within specific time. The monitoring Committee may be being constituted to check regularly construction work of the Government College Buildings in which the representatives of Higher Education Department PWD (B & R) Department.

- 5) The Committee visited newly under –construction Government Girls College Sector-12, Sonapat and inspected the construction work of College Building. During the visit of the Committee the matter of Hostel and a play ground for the Girls students was discussed.

The Chairperson of the Committee recommended that a Hostel and a play ground should be available for girls' students. The Committee directed Deputy Commissioner, Sonapat and S.E. PWD (B&R), Sonapat that they should make efforts to arrange land for Girls Hostel and play ground & inform the Committee accordingly about the availability of land action taken thereon.

**What is the criteria being adopted by Haryana Government for giving scholarship to poor students in the Government Schools (Senior Secondary Schools, High School and Primary Schools) in the state? How much scholarship is being given by the Haryana Government to poor students in the schools?**

In this connection it is submitted that criteria is adopted for giving scholarship to students belong to SC/BPL/BCA Categories studying in Haryana Government School in classes (9th to 12th) and under the scheme before release of next quarterly installment the school teacher shall see that money is not released in respect of those children whose attendance fall below 50%. Scholarship disbursed to the student on the aadhar based through PFMS to the account of Student after collect the data uploaded on PFMS Portal by the concerned DEO. The brief of the scheme and rate of scholarship are as under:-

**SCHEMES (RECURRING-NON RECURRING)(SECONDARY EDUCATION)**

**1. RAJIV GANDHI SCHOLARSHIP FOR HIGH/SENIOR SCHOOLS (EEE)**

Rajiv Gandhi Scholarship was introduced during the year 2005-06. One student each in boys category and girls category in each school in the 9<sup>th</sup> to 12<sup>th</sup> classes who stood first in the preceding class will be awarded. Under the scheme Rs. 1000/- per annum each to the students of High and Senior Secondary classes (9<sup>th</sup>-12<sup>th</sup>) are given as incentive/scholarship to encourage brilliant students provided such students have got first division.

**2. PUNJABI LANGUAGE**

Punjabi has been declared as Second Language in the State. Under this scheme, scholarships are awarded to students on basis of merit in Punjabi subject in 10<sup>th</sup> class examinations conducted by Haryana Board of School Education, Bhiwani and continuing study Punjabi in the 11<sup>th</sup> class. The Rate of scholarship for students of 11<sup>th</sup> & 12<sup>th</sup> is Rs. 75/- per month.

**3. HARYANA STATE MERIT SCHOLARSHIP SCHEME**

The scheme was introduced during the year 2009-10 on Secondary Department.

The Scheme has been revised by the Haryana Govt. w.e.f. session 2014-15 (Exam held in March 2014). Now there is no limit of 700 students and now onwards all the students will get scholarship who obtained the minimum 95% marks and above (irrespective of the Urban & Rural area (Boys & Girls). The Rate of scholarship for students of 11<sup>th</sup> & 12<sup>th</sup> is Rs. 150/- per month.

**4. To provide Free Laptop under Haryana State Merit Scholarship Scheme on the basis of Board Metric Exam conducted by Haryana School Education Board**

This scheme was launched in the year 2015-16 on the Secondary Side. The State Govt. has formulated a scheme to provide free laptop to the meritorious students on the basis of board metric exam conducted by Board of School Education, Bhiwani

Under this scheme Provide free laptop to the 500 meritorious students on the basis of board metric exam conducted by Board of School Education, Bhiwani in each category mentioned below in the table :-

**5. CASH AWARD SCHEME FOR SCHEDULED CASTE STUDENTS IN CLASSES 9<sup>TH</sup>-12<sup>TH</sup>**

The scheme was introduced in 2008-09 under this scheme Cash Award is given to Scheduled Caste students (Boys & Girls) for purchase of Stationary items, School Bags, Uniform etc. The award is given at following rates:-

Rate per student is 1450/- per annum.

**6. MONTHLY STIPENDS TO ALL SCHEDULED CASTE STUDENTS IN CLASSES 9<sup>TH</sup>-12<sup>TH</sup>**

The monthly stipend is disbursed quarterly. The incentive amount is transferred in the students account opened specially for this purpose.

**7& 8. MONTHLY STIPEND FOR BPL & BC-A STUDENTS IN CLASSES 9<sup>TH</sup> TO 12<sup>TH</sup>**

Like Schedule Caste scheme Government has decided to start monthly stipend for the student belonging to BPL/BC-A category studying in Haryana Government Schools in classes 9<sup>th</sup> to 12<sup>th</sup>.

The monthly stipend to BPL/BC-A student is given at the following rates:

- (a) All the BPL/BC-A boys students studying in classes 9<sup>th</sup> to 12<sup>th</sup> @ Rs. 150/-PM for 12 months.
- (b) All the BPL/BC-A girls students studying in classes 9<sup>th</sup> to 12<sup>th</sup> @ Rs. 300/-PM for 12 months.
- (c) All the BPL/BC-A boys students studying in classes 11<sup>th</sup> to 12<sup>th</sup> @ Rs. 200/-PM for 12 months (for Science Students).
- (d) All the BPL/BC-A girls students studying in classes 11<sup>th</sup> to 12<sup>th</sup> @ Rs. 400/-PM for 12 months (for Science Students).

The incentive amount is transferred in the students accounts opened specially for this purpose.

#### **9. PROVIDING THE INCENTIVES TO THE STUDENTS (BOYS & GIRLS) OF GRAND CHILDREN OF FREEDOM FIGHTER IN THE STATE.**

This scheme was announced by CM in the year 2010-11.

#### **10. PROVIDING FREE BICYCLE TO SC STUDENTS (BOYS & GIRLS) STUDYING IN CLASSES IX AND XI.**

A scheme for providing free bicycle for those Scheduled Caste boys and girls who take admission either in classes 9<sup>th</sup> or in 11<sup>th</sup>. In the scheme only those schedule caste students will be benefited who do not have a High School or a Senior Secondary School in their Village.

#### **11. Girls Transport Safety Policy**

The scheme was introduced during the financial year 2018-19 with the decision to provide free transportation facility only to those girl students, who are studying in classes 9<sup>th</sup> to 12<sup>th</sup>, for their safety with the stipulation of 60% or above monthly attendance. It is also worthwhile to mention here that this facility is to be provided only to those girl students who came to school from other village where a govt. High / Sr. Sec. School does not exist in the radius of 5 kilometers distance.

Further, the girl students, who have taken benefit of free bicycle under the scheme Providing Free Bicycle to S.C Students (Boys & Girls) of classes 9<sup>th</sup> and 11<sup>th</sup> scheme, will not be entitled for the said benefit under this scheme.

**THE SPOT VISIT/INSPECTION OF GOVERNMENT MODEL SANSKRITI SENIOR SECONDARY SCHOOL GANOUR, SONEPAT BY THE COMMITTEE.**

The Committee visited Government Model Sanskriti Senior Secondary School Ganour, Sonapat. The Committee discussed about infrastructure of the School, strength of the students, teaching staff, non-teaching staff, vacant posts and rules regarding admission in the School for children with the Director, Senior Secondary School, Principal and vice-Principal of the School. The Principal of the School gave the information that this School was established in 1956 as a Government Primary School and upgraded as Senior Secondary School in 1992 and converted as Government Model Sanskriti Senior Secondary School on 1st April, 2007. The Principal told that the total strength of students during the session 1919-2020 was 1135 from Primary to 10+2 classes. That strength of the students was increased 1135 to 1466 during Covid-19 and that's why there are shortage of buildings for the students in this school. During the discussion of the Committee a shortage of the teaching staff came into notice of the Committee. The Committee directed the Director, Senior Secondary School that the shortage of the teaching staff should be solved very soon. The Director replied that the Department has rationalization policy, according to this policy we adjust the teachers divided by the strength of students. The Director, School Education Department assured that there will be no shortage of the teaching staff after this process in new sessions.



## School Education Department

### Observations/Recommendations of the Committee

1. The Committee discussed the matter of Government Model Sanskriti Schools during the course of oral examination of School Education Department. The Additional Chief Secretary, School Education Department told that the Government Model Sanskriti Schools are affiliated with C.B.S.E. Delhi and the students are being taught through English Medium. The matter of C.B.S.E. Board and Haryana Education Board was also discussed with School Education Department and Department told that the attraction of students and parents is more towards the C.B.S.E. Board. The Highgrade infrastructure is provided in the Government Model Sanskriti Schools and availability of the teachers is also in the priority list of the School Education Department. Some of the members have discussed that such system affect the quality education of Government Schools in all ways. The facility of the Government Schools will be shifted to Government Model Sanskriti Schools. That's why they will be ignored.

Therefore, the Committee observed that fee structure is beyond the reach of very poor people and recommended that the fee structure should be in the reach of poor people so that they can send their children in Government Model Sanskriti Schools. The Committee's great concern about the Government Schools and recommended that School Education Department should provide the facilities of infrastructure and teachers in Government Schools also. The Chairperson of the Committee directed that School Education Department should form a Committee that should conduct a survey of some the villages to find out whether the numbers of students are increased in the Government Schools inspite earlier strength of the students.

2. During the course of oral examination, the Committee discussed the matter of the Shortage of the Teachers in the Government Schools. The Committee observed that how it is possible to give quality education and how can we built bright future to the student who read in the Government Schools. The Committee noticed that in every district in the state a number of vacant posts are laying vacant of the teachers in the Government Schools. It has also come into the notice of the Committee that infrastructure in the Government Schools is not up to the mark. There are crumbling buildings in some of the Government Schools.

The Committee recommended that the quality education in the Government Schools must be provided to the students and the School Education Department should make serious efforts to fill up the number of vacant posts of teachers in the whole state. The Committee also recommended that there is great need to improve the infrastructure of the Govt. Schools in order to provide better quality of education and facilitate to the students.

3. During the oral examination of School Education Department when Members of the Committee raised the question of vacant posts of the teachers and to provide infrastructure in the Government Schools then Additional Chief

Secretary, Government of Haryana, School Education Department replied that the Department has its limited budget and only 20 percent budget can spent on infrastructure and new recruitment.

The Committee recommended that the budget of School Education Department should be increased so that the new recruitment of teaching staff can be completed for good education for the children for their bright future.

### **SPOT VISIT/INSPECTION AND MEETING AT ITI SONEPAT OF THE COMMITTEE**

The Subject Committee on Education, Technical Education, Vocational Education, Medical Education and Health Services was conducted a spot visit/inspection and meeting at Sonapat, Haryana. The Committee held a meeting with Director General, Additional Director, Skill Development Industrial Training Department and Deputy Commissioner, Sonapat in the PWD Rest House, Sonapat. During the course of oral examination Additional Director, Skill Development Industrial Training Department brief the Committee that the Department is running Haryana Skill Development Mission and identified 100 Training Providers. The students can get placement in the private Companies and also can apply in the Government Jobs. The Department got budget Rs. 867 crore and Rs. 250 crore supplementary the financial year 2021-2022. The Chairperson of the Committee asked the Director General the main goal of the Skill Development Industrial Training Department. In reply the Director told the Committee that our Department not only to give education and training but also help the students to get jobs. The Department got signed MoU with industries in which students can get employment. In the meeting one of the Member Shri Indu Raj pointed out about the ITI Village Mudlana District Sonapat. Then Chairperson recommended that the building of the ITI Village Mudlana District Sonapat should be in working.

The Committee proceeded for the inspection of ITI Sonapat where the Principal gave a brief presentation before the Committee. He informed the Committee about the vision, measures taken in view of the employment by Government Industrial Training Institute, Sonapat, introduction of ITI's Administrative Structure in Government Industrial Training Institute, Sonapat, special facilities for the female Trainees, National Apprenticeship Promotion Scheme, Apprentices Act, 1961, Roles of Assistant Apprenticeship Advisor, Number of job fair organized by District Sonapat from 1<sup>st</sup> August, 2020 to 30<sup>th</sup> November, 2021, status of Establishments/Industries registered on Apprenticeship Portal & seats created for Apprenticeship, follow up status of Trainees admitted in Session 2018-19 (two years Trade) and 2019-20 (one year Trade), status of MoU signed with Industries and Trainees sent for on job Training etc. The Principal told that there is no problem for placement for the students who passed ITI with training. Smt. Nirmal Rani, member of the Committee raised the point regarding the exploitation of the students who got job in Industries. The Industrialists complete them to work at least 12-12 hours in a day on low salary. That's why most of the ITI passed students do not prefer to do job in the Private Industries. The Chairperson of the Committee advised that the awareness camps should be organized in this regard. Shri Shamsheer Singh Gogi, a Member of the Committee suggested that the minimum salary should be given by Industries as per Haryana Government policy.

After the meeting, the Committee visited the class rooms of Industrial Training Institute, Sonapat as Computer Lab, Carpenter and Motor Mechanic classes.

## **SKILL DEVELOPMENT AND INDUSTRIAL TRAINING DEPARTMENT**

### **Observations/Recommendations of the Committee**

1. The Committee During the oral examination of Skill Development and Industrial Training Department observed that the students who passed the ITI courses with training have to face frustrations due to exploitation by the employers of Industries. The employees have to do their duties at least 12-12 hours in a day and get low salaries. That's why most of the skilled workers don't wish to do job in such Industries.

The Committee recommended that the minimum salary should be fixed for the skilled workers in private Industries as per guidelines of the Haryana Government. The Committee recommended that the exploitation of the skilled workers must be stopped and there should be a monitoring Committee to check such matters. The Chairperson of the Committee recommended that awareness camps should be organized to aware the students.

2. During the course of oral examination of Skill Development & Industrial Training Department the Committee discussed the matter of the students who passed the ITI courses with requisite training in search of placement. The Committee visited/inspected the ITI, Sonapat and noticed the training system & appreciate the efforts are being done by ITI, Sonapat. The Committee also discussed the matter to create the interest of girls students in the courses of ITI's. The Chairperson of the Committee raised the matter of the schemes & amendment in schemes run by the Haryana Government.

The Chairperson of the Committee directed/recommended that the data of all the students who passed the ITI courses should be kept in the concerned Deputy Commissioner offices so that the requirement of skilled workers can be fulfilled from such students. In this way the unemployment can be curtailed. The Chairperson of the Committee recommended that Skill Development & Industrial Training Department should install a big screen in all ITI's of the state through this all informations regarding all courses which are available in Institutes and also scopes in the job of such courses should be displayed on the screen so that the benefit of such schemes should be reached to the more people. The Committee also recommended that a common telephone no. /mobile no. should display in every ITI notice board through which every student can get all type of information's for his bright future.

3. During the oral examination of the Committee the Skill Development & Industrial Training Department gave information about the MoU signed between Industrialists and the Department told that the Department will be achieved a target of 400 MoU's. The Committee further discussed that how many public representatives attended the programme. The Committee observed that in such type of programme the representatives of public as all concerned MLA's, MP's and Municipal Councilors can give their contribution to aware the people.

The Chairperson of the Committee strongly recommended that the Skill Development & Industrial Training Department should invite all the

representatives of public as all concerned MLA's, MP's and Municipal Councilors in the Government programmes such as the Department could held in the form of Workshop at Faridabad. The Committee recommended that public representatives can give their contribution to aware the people and the schemes of the Government can reach to the people.

4. The Committee discussed on National Apprenticeship Promotion Scheme (NAPS) during the course of oral examination of the Committee. Apprenticeship act, 1961 provides to create training facilities in different trades in various Establishments, regulate and control of training of apprentices. According to this act Establishments have to engage minimum 2.5 percent and maximum 15 percent number of apprentices of their total manpower appointed either directly or indirectly.

The Chairperson of the recommended that Apprenticeship act, 1961 should be implemented & strengthened more effectively so that all the students who passed ITI courses can complete their apprenticeship through Government sector or Private sector. The Chairperson of the Committee also recommended these all schemes should be implemented on ground level not in papers only so a complete record of the Industries should be maintained by Skill Development & Industrial Training Department.

5. The Committee during the spot visit/inspection of ITI Sonapat noticed shortage of facilities in ITI's of the state. The Principal ITI Sonapat told that the guest teachers from other institutes teach the Student of ITI Sonapat and the students have to face problems due shortage of staff.

The Committee recommended and directed that the quality education in ITI's must be provided to the Students so the Skill Development & Industrial Training Department should take necessary steps to fill up the large number of vacant posts of the teaching staff in ITI's. The Committee also recommended that the teachers whose work and results are excellent and take keen interest to improve the standard of Education in Government ITI's should be awarded or given incentives.

3. How many Oxygen Plants were established during the 1<sup>st</sup> wave and second wave of Covid-19 in the state of Haryana? Give the details where they were established what is capacity of these Oxygen plants
4. How many Ventilators have been received from PMO office to the Health Department of Haryana and where they have been established? How many Ventilators are in working position at present? What was position of the operational staff to operate the above said Ventilators in the state when these were received? The details to be supplied to the Committee?
5. What is the position of Medical staff/Paramedical staff at this time in the state? The details to be supplied District-wise. What is the proposal for recruitment of Medical staff/Paramedical staff to tackle the third wave of Covid-19, epidemic in the state?
6. Give the details of the Vaccine which are used in the state for Covid-19, epidemic at this time. What is the plan of Vaccination in future of Health Department? Will the Department use any other Vaccine beyond use at present for Covid-19? If yes, supply the plan chart of this.
7. How many Oxygen Concentrators have been purchased by the Health Department during the Covid-19 and how many Oxygen Concentrators have been received from CSR/donation by the Department?
8. Will the Health Department increase the Vaccination Camps in future and what is plan for Rural and Urban areas for Vaccination?
9. Whether the prior permission to organize the Blood Donation camps has been taken from the concerned CMO's? Is the record of the blood donors maintained properly and same is submitted in CMO's office on the same day or not?
10. Whether the record of the blood collected by any organization is maintained properly and the name of the persons to whom it is given is maintained and the same is sent to CMO's office or not?

11. Whether the complete data of blood donors and blood recipients is registered in the concerned CMO's office or not?

## HEALTH SERVICES DEPARTMENT

### Observations/Recommendations of the Committee

1. The Committee discussed regarding Covid-19, effects on human life and precautionary measures taken by the Health Department during the oral examination. The Committee discussed about Covid Vaccinations camps, Nodal Officers and arrangements for the Covid-19, patients. Additional Chief Secretary, Health Services Department told that the Government had taken legal steps and declared it an epidemic under act-1987. Health Department also had given guidelines about Medicines, home isolations to the patients who were suffering from Covid-19.

The Committee recommended that Health Department should make efforts to increase testing for Covid-19 and Vaccination Camps. The Committee also directed the Department that appropriate preparation for the second wave should be made as well as concerned of Ventilators, Oxygen cylinders and Isolation centres for the patients.

2. During the course oral examination of Health Department the matter of blood donation camps organized by private organizations was discussed and Committee found that there is not a proper record of blood donors in the concerned C.M.O. offices in the state.

The Chairperson of the Committee recommended that a proper record of Blood donation camps and donors and recipient with their mobile no.s should be kept in concerned C.M.O. Offices so that the donor should get more satisfaction. The Committee directed Health Services Department that a proper monitoring system should be there so that the sale and purchase of the blood can be stopped.

3. In the oral examination of the Committee the matter of Dengue cases discussed. Additional Chief Secretary, Health Services Department replied that in current year the dengue cases are more than previous years because the Monsoon season was longer that why 5377 cases were reported while in 2020 dengue cases reported 1377. He assureds the Committee that now Health Department will be done well in this field. There are 27 Testing Labs in the State and in Government Hospitals there is no any charge of dengue test. The Committee discussed the side effects of fogging also.

The Committee recommended that the Health Department should make aware people about side effects of foggings in the rural areas.

4. The Committee recommended that Health Department should make a policy with the coordination of Haryana Shehri Vikas Pradhikaran Department. According to this policy the private Hospitals who have got land on subsidized rates from Haryana Shehri Vikas Pradhikaran Department should adopt such patients who are suffering from Thalassemia and Hemophilia for free/concessional rates treatment/medical facilities. The proper registration

should be maintained by the concerned C.M.O,'s. The Department should also be proposed before the Government to provide the financial aid/pension to the patients who are suffering Thalassemia and Hemophilia disease. The financial aid/pension should be given to such patients whenever Thalassemia and Hemophilia diseases are identified and the conditions should be removed in this regard.

5. The Committee discussed the matter of free education in Government Schools, Colleges and Universities of the patients who are suffering from Thalassemia and Hemophilia. The Chairperson of the Committee discussed with Health Department that a whole family has to suffer with the presence of such patient who are suffering from Thalassemia or Hemophilia.

Therefore, the Committee recommended that the free education must be provided to the patients who are suffering from Thalassemia or Hemophilia. The Health Department should make a District-wise list of the patients and with the coordination of School Education Department & Higher Education Department make it possible to provide free education in government Schools, Colleges and Universities of the patients who are suffering from Thalassemia and Hemophilia.

**SPOT VISIT/INSPECTION AND MEETING AT ITI  
SONEPAT OF THE COMMITTEE**

The Subject Committee on Education, Technical Education, Vocational Education, Medical Education and Health Services was conducted a spot visit/inspection and meeting with Deputy Commissioner, Nuh, the Director General, Health Services Department regarding all arrangements and steps taken by the local Administration to combat the Covid-19, Pandemic at Nuh (Mewat) Haryana. The Chairperson of the Committee asked about the total population of District Nuh. The matter of Lab Technician's was discussed and the Director General, Health Services Department assured that in future the qualified Lab Technician will be recruited. After that Chairperson asked about the Vaccination centres of Covid-19. The Chief Medical Officer, Nuh told about that all PHC's and CHC's in the District. The Committee directed the Health Services Department that women and handicapped persons should be awarded about Medical facilities given by the Department. The Chairperson of the Committee said that the Government of Haryana has committed great efforts to prevent this pandemic of Covid-19, but I noticed that the Vaccination rate is not upto the mark in this District. The Chairperson further directed the Health Services Department that the Vaccination rate should be increased with the involvement coordination of social persons as Sarpanches/Members of the villages. The Committee noticed that the disease of anemia, T.B. malnutrition's are among the women at large scale in Nuh. The Committee directed the Health Department that it should come forward to curb these diseases in this area. The Director General, Health Department assured that they are trying to find out all possible ways how can they improve their health. The Health Department is providing them iron tablets, supplements, and vitamins etc but they will give more focus in this direction in future. The Chairperson directed Health Department and other local Administrations that they all should work together to improve Health system in Mewat area so that the Red Zone can be cleared. The Committee made the recommendations/observations in the end.

### **Observations/recommendations of the Committee**

1. The Committee discussed the matter of Vaccination of Covid-19 in District Nuh (Mewat) and noticed that the Vaccination rate among the people is not up to the mark. The Chairperson of the Committee suggested that the local Administration make sure to involve in Vaccination campaign to the social organizations & public representative as MLA's, ex-MLA's, Municipal Councilors and ex- Municipal Councilors of the society to motivate the common man for this noble act and should increase the Vaccination rate. The Chairperson of the Committee also suggested that the separate camps of Covid-19, for women Vaccination should be organized by the Health Department.
2. The Committee discussed the matter of shortage of Doctors and paramedical staff in district Nuh (Mewat). There is only two Technicians are on regular basis and 67 Technicians are recruited on the basis of outsourcing policy that is why patients have to suffer. The Committee suggested that the Health Services Department should be recruited regular Doctors and Paramedical staff in District Nuh (Mewat) at earliest.

The Committee suggested that an operation theater should be made in Civil Hospital, Manikheda and also posted a regular Ophthalmologist Doctor in civil Hospital, Mandikhera.
