- a) the number of employees working on the post of driver in Municipal Corporation Faridabad of Faridabad-89 Assembly Constituency togetherwith the details of vehicle on which the said drivers are posted;
- b) the date on which the last recruitment of above said drivers was made by the Government together with the name of agency through which the said recruitment was made; and
- c) the number of employees working on the post of electrician in Municipal Corporation, Faridabad together with the details of work allotted to them after the maintenance work of street lights was given to private contractors ?

Sir,

- a) There are 29 drivers (Regular and outsourced) specifically working in the area falling in Faridabad-89 Assembly Constituency of Faridabad. The list of said drivers together with the details of vehicles on which they are posted is placed at **Annexure-A**.
- b) The last recruitment of regular driver was made directly through Employment Exchange on 19.08.1992 by Municipal Corporation, Faridabad. Presently, there are 41 regular drivers working in Municipal Corporation, Faridabad. They were recruited through Employment Exchange, regularized under Government Policy and absorbed from other cadres.

The detail is placed at **Annexure-B**. In addition, 106 Drivers have been engaged by Municipal Corporation, Faridabad through Outsourcing Manpower Agency i.e., M/s. ARC Security Solutions Pvt. Ltd.

- c) There are 03 numbers of Electricians working on regular basis and 2 Electricians have been engaged through Outsourcing Manpower Agency i.e., M/s. ARC Security Solution Pvt. Ltd. The details of work allotted to them is placed at **Annexure-C**.

- क) नगर निगम, फरीदाबाद में वर्तमान में कुल 29 चालकों को विशेष रूप से नगर निगम, फरीदाबाद के अर्न्तगत आने वाले फरीदाबाद-89 विधानसभा निर्वाचन क्षेत्र में कार्यरत किया हुआ है। उक्त चालकों की सूची वाहनों के विवरण सहित अनुबंध-‘ए’ पर संलग्न है।
- ख) नगर निगम, फरीदाबाद द्वारा 19.08.1992 को सीधे तौर पर रोजगार कार्यालय के माध्यम से चालक के पद की भर्ती की गई थी। वर्तमान में नगर निगम, फरीदाबाद में 41 नियमित चालक कार्यरत हैं, जिनकी भर्ती

सीधे तौर पर रोजगार कार्यालय के माध्यम से, सरकार की नियमितकरण निति के तहत तथा अन्य संवर्गों से समायोजन द्वारा की गई है, जिनका विवरण अनुबंध-‘बी’ पर संलग्न है। इसके अतिरिक्त, 106 चालकों को नगर निगम, फरीदाबाद द्वारा आउटसोर्सिंग मैनपॉवर एजेंसी मैसर्स ए0आर0सी0 सुरक्षा समाधान प्राइवेट लिमिटेड के माध्यम से लगाया गया है।

- ग) नियमित आधार पर 03 विद्युतकार कार्यरत हैं और 2 विद्युतकार आउटसोर्सिंग मैनपावर एजेंसी मैसर्स ए0आर0सी0 सुरक्षा समाधान प्राइवेट लिमिटेड के माध्यम से लगाए गए हैं। इन कर्मचारियों को आवंटित कार्य का विवरण अनुबंध-‘सी’ पर संलग्न है।
