Sir, there is no CM Announcement regarding construction of the Community Centre and to develop the park on the Horticulture land in front of Jayanti Devi Temple of Jind City. However, Municipal Council Jind has identified a site measuring 124 Kanal 4 Marla in front of Jayanti Devi temple for development of park and construction of Community centre. The said land belongs to Horticulture Department and Horticulture department, Haryana has been requested to transfer the said land to Municipal Council, Jind. At present, a temporary Nandishala is functioning on the said land.

Municipal Council, Jind will initiate further steps to materialize the said proposal only after Horticulture Department transfers the land to Municipal Council, Jind and temporary Nandishala on the identified land is shifted.

EXECUTIVE SUMMARY

- ➤ There is no CM Announcement to construct the Community Centre and to develop the park on the Horticulture land in front of Jayanti Devi Temple of Jind City.
- The assembly question related to said matter was also listed as a starred question *747 during Budget session-2021.
- At present, this Nandishala having 3417 No. of cattle is functioning on this land which needs to be shifted.
- Horticulture Department, Haryana has sent the case for obtaining the consent of Government to transfer the said land measuring 124 Kanal 4 Marlas near Jayanti Devi, Temple.
- > Horticulture Department has evaluated the cost of land to be approximately Rs. 70.00 cr.
- There are no funds available with Municipal Council, Jind for depositing to Horticulture Department for getting the land transferred to Municipal Council, Jind and financial support from the Government would be required.
- Municipal Council, Jind will initiate further steps to materialize the said proposal only after Horticulture Department transfers the land to MC Jind & temporary Nandishala is shifted alongwith arrangement of funds that are to be deposited to Horticulture Department, Haryana for getting the land transferred in the name of Municipal Council, Jind.
