- a) NHAI has appointed DPR consultant for taking long term remedial measures on accident prone points near Thana Chhappar and Karera Khurd road. DPR work is in progress and proposal shall be framed after completion of DPR.
- b) Since the proposal is yet to be framed by NHAI, no time frame can be given at this stage.

## **EXECUTIVE SUMMARY**

1. 37 National Highways with a total length of about 3014.214 km. pass through the State of Haryana. When the Haryana State was formed, only 5 National Highways with a total length of 655.261 Kms. were passing through the State. Now, the total number of National Highways in the State has increased to 37 with a total length of 3014.214 kms.
2. The responsibility for upkeep, maintenance and up gradation 5 National Highways i.e. NH-709-Extn., part NH-148-B, part NH-248A, NH-71B, NH-334D having total length of 330.032 km has been entrusted by Ministry of Road Transport & Highways (MoRTH) to Haryana PWD B&R. The works on these National Highways are taken up through the funds provided by Ministry of Road Transport & Highways (MoRTH). Overall control over these National Highways is under MoRTH and Haryana PWD B&R is executive agency for the works.
3. The responsibility for National Highways No. 1, 2, 8, 10, 11, 22, 54, 64, 65, 71, 71A, 72, 73, 73-A, 248-A, 334-B, 703, part 148-B, 709-A, 352-A, 444-A, 21-A, 248BB, 152A, 907G, 352R, 352W, 148N, 152D, 709AD, 148NA, 344N, 344P, 148A & NE-2 measuring 2684.182Kms. is entrusted to National Highway Authority of India (NHAI). Overall control over these National Highways is exercised by NHAI.
