## To Construct Community Centre

\*36 Smt. SHALLEY CHAUDHRY (Nariangarh):

Will the Development and Panchayats Minister be pleased to state that :-

- a) whether it is a fact that there is no community centre for scheduled castes in any of the village of Nariangarh Assembly Constituency for organizing their religious programmes; and
- b) if so, whether there is any proposal under consideration of the Government to construct community centre for scheduled castes in the abovesaid villages togetherwith the details thereof ?

**DEVENDER SINGH BABLI, DEVELOPMENT & PANCHAYATS MINISTER**

- a) No sir, community centres existing in villages of Nariangarh Assembly Constituency can be used by any community for organizing their social/religious programmes.
- b) There is no proposal under consideration of the Government to construct community centres for scheduled castes only in the abovesaid villages.
