To Shift SIASTE in its own Building

*1 Smt. GEETA BHUKKAL (Jhajjar):

Will the Higher Education Minister be pleased to state:-

- a) the time by which the State Institute of Advanced Studies in Teacher Education (SIASTE), Jhajjar usually known as PRARAMBH which is running in rented building since 2013 is likely to be shifted to its own building;
- b) the present faculty position of teaching and non-teaching staff in the said institute; and
- c) the present position of admission in the abovesaid institute at Jhajjar?

To Conduct the Socio-Economic Survey

*2 Smt. KIRAN CHOUDHRY (Tosham):

Will the Chief Minister pleased to state :-

a) whether the Government intend to conduct the Socio-economic survey in State on the pattern of Bihar; and

b) if so, the details thereof?

To Construct Police Station
