Details Regarding BPL Cards

***41 Sh. Shishpal Keharwala (Kalanwali):**

Will the Minister of State for Food, Civil Supplies & Consumer Affairs be pleased to state: -

- a) the number of new BPL cards issued during the period from 01 January, 2024 to 31 July, 2025 in the State and the number of BPL cards discontinued during the said period;
- b) the total number of BPL cards in State on 31 March, 2025 and the number of BPL cards at present; and
- c) the basis on which BPL cards mentioned at 'a' above have been discontinued?

Construction of New Hospital Building

***42 Sh. Sh. Mukesh Sharma (Gurgaon):**

Will the Health Minister be pleased to state: -

- a) the present status of the construction of the new building of the Civil Hospital in Gurugram, in front of the old Municipal Corporation Office; and

b) the reasons for the delay in its completion and the names of the officers responsible for such delay?

Details of Chakbandi in Village

***43 Sh. Manmohan Bhadana (Samalkha):**

Will the Revenue & Disaster Management Minister be pleased to state: -

a) whether the Government has carried out consolidation of land (Chakbandi) in village Nanheda of Tehsil Bapoli falling under the Samalkha Assembly Constituency; if so, the total area consolidated;

b) whether any part of this village's land has, for any reason, come under the territory of the neighbouring State of Uttar Pradesh;

c) the extent of such land that has gone into Uttar Pradesh and whether consolidation has been carried out for that land; if not, the reasons therefor;

d) whether any compensation or alternate land has been given in lieu of such land; if so, the details thereof; and

e) if not, the reasons therefor?

To Construct a New Bus Stand

a) whether it is a fact that heavy waterlogging occurred in Bawani Khera town every year even after light to moderate rainfall, resulting in water entering shops, houses, and streets, disrupting commercial activities and causing repeated damage to property; and

b) whether there is any proposal under consideration of the Government to formulate any permanent solution to solve the abovesaid problem; if so, the details thereof?
