To Control Waterlogging in District Nuh

***41 Ch. Aftab Ahmed (Nuh):**

Will the Public Health Engineering Minister be pleased to state: -

a) whether any special measures have been taken by the Government in Nuh during the year 2025 to solve the problem of waterlogging caused due to excessive rainfall; if so, the details thereof;

b) the time by which water was drained out from the areas of Nuh, which were affected from waterlogging due to excessive rainfall in the year 2025 togetherwith the details thereof; and

c) whether the Government has proposed any special plan for controlling waterlogging in Nuh in future; if so, the details thereof?

To Open Roadways Sub-Depot

***42 Sh. Anil Yadav (Kosli):**

Will the Transport Minister be pleased to state: -

(a) whether it is a fact that although a Roadways Workshop has been established in Kosli, it is not functioning properly; and

(b) whether there is any proposal under consideration of the Government to open a Roadways Sub-Depot at Kosli; if so, the time by which abovesaid proposal is likely to be materialized?

To Construct an Alternate Road

***43 Sh. Devender Kadyan (Ganaur):**

Will the Public Works (B&R) Minister be pleased to state: -

a) whether there is any proposal under consideration of the Government to construct an alternate road from village Barhi to Khanpur Road in order to solve the problem of traffic congestion in Ganaur town; and

b) if so, the time by which the aforesaid road is likely to be constructed?

The Details of Waste Collection Agency

***44 Sh. Devender Hans (Guhla):**

Will the Urban Local Bodies Minister be pleased to state: -

a) whether it is a fact that despite the evidence of corruption and violation of rules by the Sugam Swachhta Agency engaged in waste collection in Municipal Committee, Siwan, the tender awarded to this agency has not been cancelled by the Government; if so, the reasons thereof;

b) whether the Government is aware that the said agency has failed to comply with contractual conditions such as deploying the required number of vehicles and providing safety gear including gloves, masks and PPE kits to its workers; if so, the reasons for which the abovesaid violations have been ignored by the Government; and

c) whether it is also a fact that the waste collection and aggregation work in the Karnal Cluster has been awarded by the Government to a single agency for a period of 22 years; if so, the basis, policy framework and selection process adopted for awarding this long-term contract alongwith the details thereof?

b) whether the estimates for the repair/re-construction of the abovesaid roads have been prepared and sent to the Government; if so, the time by which the construction/repair work of the abovesaid roads is likely to be started; and

c) if not, the time by which the aforesaid estimates are likely to be prepared and sent to the Government?

Details of Leaked and Cancelled Examination Papers

***46 Sh. Aditya Devilal (Dabwali):**

Will the Chief Minister be pleased to state: -

a) the name of the post for which the examination papers conducted by the Haryana Public Service Commission and Haryana Staff Selection Commission have leaked from the year 2014 to 2024-25 in the State togetherwith the year-wise and paper-wise details thereof;

b) the name of the recruitment which were cancelled due to paper leak and irregularities found in the recruitment by the Court togetherwith the details thereof;

c) the action taken by the Government against the Officers/Officials and other accused who were found involved in the abovesaid paper leak cases togetherwith the post-wise name of the said Officers/Officials and other accused alongwith the details thereof; and

d) the details of the cases related to (a) and (b) above in which the legal action has been taken/got stayed/got cancelled togetherwith the year-wise details thereof?

The Details of Gram Gyan Kendras

b) the list of the routine laboratory tests currently provided to the patients in the said hospital; and

c) the per day average number of OPD patient visits are being recorded by the said hospital?

To Complete the Construction Works of the Hospital and PHCs
